CHAP. 100. mechanic arts, at Orono, with one copy each of the Maine reports so far as they can be furnished without detriment to the state library.

Approved February 24, 1875.

Chapter 100.

Resolve in favor of the Maine state college of agriculture and the mechanic arts.

College of agri-
culture, in favor
of.

Resolved, That the sum of ten thousand five hundred dollars be and the same is hereby appropriated for the purpose of paying existing debts of the Maine state college of agriculture and the mechanic arts, erecting new buildings, purchasing apparatus, farm expenses, experiments and improvements, instruction, repairs of buildings, furniture for students' rooms, grading grounds, and making improvements for said college. *Provided however*, that the trustees of said college shall pay from this appropriation the debts now against said college, and shall not under any circumstances contract any further debts in behalf of said college.

Chapter 101.

Resolve in favor of George R. Fernald.

George R. Fer-
nald, to pay ex-
penses of sickness

Resolved, That the treasurer of state be authorized to audit, allow and pay the necessary expenses incurred for board, nursing and medical attendance furnished George R. Fernald, a member of this house, from Wilton, now confined to his room by sickness, requiring extraordinary care. The sum hereby appropriated not to exceed one hundred dollars.

Chapter 102.

Resolve relating to a new insane hospital.

Additional ac-
commodations for
the insane, to
provide for.

Resolved, That the governor, with the advice of council, be and hereby is authorized and directed to appoint a committee consisting of three persons, whose duty it shall be to consider what measures shall be adopted to provide suitable additional accommodations for the insane; and in furtherance of this end if

they shall consider it advisable, to purchase the United States marine hospital, near Portland; or if they shall not deem this advisable, to select a suitable location for a new insane hospital, and report to the next legislature. CHAP. 103.

Chapter 103.

Resolve in favor of military purposes.

Resolved, That the sum of six thousand five hundred dollars be and the same is hereby appropriated for military purposes. Military purposes, appropriation for.

Approved February 24, 1875.

Chapter 104.

Resolve establishing the valuation of the towns of Berwick and North Berwick, in the county of York.

Resolved, That the number of polls set to the town of Berwick be four hundred and twelve, and the value of estates six hundred and six thousand one hundred and two dollars; and that the number of polls set to the town of North Berwick be three hundred and seventy-six, and the value of estates six hundred and eight thousand one hundred and fifty-four dollars, and that all state and county taxes hereafter shall be assessed accordingly. Valuation of Berwick and North Berwick, established.
