CHAP. 236.

SECT. 3. This act shall take effect when approved.

Approved February 1, 1876.

Chapter 236.

An act authorizing Gilbert H. Manchester, D. J. Manchester and A. L. Manchester to build and maintain fish weirs in Somes' Sound, Mount Desert.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :

SECT. 1. Gilbert H. Manchester, D. J. Manchester and A. L. Manchester of Mount Desert, are hereby authorized and empowered to erect and maintain weirs between Sargent's Ledge so called, in Somes' Sound, and Gilpatrick's farm in the town of Mount Desert.

Gilbert H. Manchester and others to erect weirs.

SECT. 2. This act shall take effect when approved.

Approved February 3, 1876.

Chapter 237.

An act to change the name of the town of Dalton, to Ashland, its former name.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :

The name of the town of Dalton, in the county of Aroostook, is hereby changed to Ashland, its former name.

Dalton, name of town of, changed to Ashland.

Approved February 3, 1876.

Chapter 238.

An act to prevent fishing in Adams pond in the town of Bridgton.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :

SECT. 1. All persons are forbidden to take fish of any description, in any manner, from Adams pond in the town of Bridgton, county of Cumberland, for the term of five years from the passage of this act.

CHAP. 239.

Penalty for
violation.

SECT. 2. If any person shall violate the provisions of this act, he shall forfeit and pay the sum of five dollars for each fish so taken, to be recovered by complaint before any trial justice in said county of Cumberland, one-half to the use of complainant, and the other half to the use of said town of Bridgton.

SECT. 3. This act shall take effect when approved.

Approved February 3, 1876.

Chapter 239.

An act to make valid the doings of the town of Lyndon, in the county of Aroostook.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :

Lyndon, certain
doings of town of,
made valid.

SECT. 1. So much of the doings of the town of Lyndon, at its meeting held November twentieth, eighteen hundred and seventy-five, as relates to and is explanatory of its vote upon the rate of interest to be paid upon the loan in aid of the Aroostook River Railroad, at its annual March meeting, eighteen hundred and seventy-five, is hereby made legal and valid.

SECT. 2. This act shall take effect when approved.

Approved February 5, 1876.

Chapter 240.

An act for the preservation of fish in Little Sebago lake, situated in the county of Cumberland.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :

Protection of fish
in Little Sebago
lake.

SECT. 1. All persons are prohibited from fishing or taking any fish in any way from Little Sebago lake, or its tributaries, situated in the county of Cumberland, between the first day of October and the first day of the following June, or taking any fish at any time except by the ordinary process of angling with single bait, hook and line, or artificial fly.

Penalty for
violation.

SECT. 2. Any person who shall violate any of the provisions of this act, shall forfeit the sum of fifteen dollars, to be recovered by complaint before a trial justice, one-half to the use of the town where the offence is committed, and one-half to the person prosecuting therefor.

SECT. 3. This act shall take effect when approved.

Approved February 7, 1867.
