CHAP. 265.

Chapter 265.

An act setting off Joshua M. Leighton's estate from the Town of Steuben, and annexing the same to the Town of Milbridge.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :

Steuben, portion of town of, annexed to Milbridge.

SECT. 1. On and after the passing of this act, so much of the town of Steuben, in the county of Washington, as is contained within the following bounds, is annexed to the town of Milbridge, in said county of Washington, viz : Commencing at the shore of Pigeon Hill Bay, on the line between Steuben and Milbridge, thence running westerly by the shore to Clark's Brook, so called, thence northerly by said brook fourteen rods, thence westerly forty rods, thence northerly forty rods to a corner, thence easterly eighty rods to said line between Steuben and Milbridge, thence southerly to the first bounds, containing twenty acres more or less, together with the buildings thereon ; and the inhabitants set off to said town of Milbridge shall there exercise and enjoy all the rights and privileges of, and be subject to the same duties and regulations as the other inhabitants of said town ; and shall be held to pay all assessments upon them, remaining unpaid, to said town of Steuben, prior to this act, and the inhabitants so set off shall be entitled to the benefit of the money raised for the support of schools in the tract so set off, which has been assessed previous to and remains unexpended at the time of the passing of this act.

Rights, privileges and liabilities of inhabitants.

SECT. 2. This act shall take effect when approved.

Chapter 266.

An act establishing the division line between the towns of Cornish and Parsonsfield.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :

Cornish and Parsonsfield, town lines between, established.
Bounds courses and distances.

SECT. 1. That the following shall be the division line between the towns of Cornish and Parsonsfield, viz : Beginning at the northwest corner of Limerick, at Hornbeam corner, so called, thence running, as the needle now points, ten and one-eighth degrees east, four hundred and eighty-nine rods, to a stone monument on the north side of the road near East Parsonsfield ; thence north, eleven and three-fourths degrees east, two hundred and twenty-eight rods, to a stone monument on the south side of the road near Pendexter's mills ; thence north, eleven and three-fourths degrees east, two hundred and fifty-nine rods to a stone monument on the north side of the road near where Kelley once lived ;

thence, same course, ninety-seven rods to a stone monument in a seam in the ledge on top of Kennard's mountain; thence north, eight and one-half degrees east, eighty-nine rods to a stone monument near David Pendexter's barn; thence north, four and one-half degrees west, three hundred fifteen and one-half rods, to an angle in a stone wall on Morrill's island, so called, to a stone monument; thence north, four and one-half degrees east, one hundred and one rods, to a stone monument on the south side of the road near the corner of Levi Morrill's field; thence north, eleven degrees east, seventy-two rods, to a stone monument at the Gore; thence north, thirteen degrees east, one hundred and ninety-eight rods, to a stone monument near Merrill's bridge; thence north, twelve degrees east, one hundred and ninety-four rods, to a stone monument on the north side of the road leading from Cornish to Porter, near Pendexter's mills; thence north, three degrees east, twenty-six rods and twenty links, measuring on a curved line, to a hemlock stump and stone monument on the bank of the Great Ossipee river.

SECT. 2. This act shall take effect when approved.

Chapter 267.

An act to make valid the doings of Theodore Taylor, a Trial Justice.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

SECT. 1. The doings of Theodore Taylor, of Burlington, county of Penobscot, as trial justice, from February nineteenth, eighteen hundred and seventy-five, to January fifteenth, eighteen hundred and seventy-six, are hereby made valid.

SECT. 2. This act shall take effect when approved.

Chapter 268.

An act to amend an act entitled "an act to incorporate the Maine Dairymen's Association," approved February twentieth, one thousand eight hundred and seventy-four.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

The Maine Dairymen's Association shall have the same rights of representation on the Board of Agriculture as is now enjoyed by the Maine State Agricultural Society and Pomological Society.
