CHAP. 168.

Chapter 168.

Resolve in favor of W. S. Evans.

W. S. Evans, in
favor of.

Resolved, That when Winfield S. Evans shall have shown to the land agent that he, W. S. Evans, is the actual owner of certificate of lot number eight, range four, in the east half of township number two, range five, and shall have paid to the land agent the sum of twenty-five dollars, the land agent be and is hereby authorized to convey, by deed, lot number eight, range four, in the east half of township number two, range five, to the said Winfield S. Evans.

Chapter 169.

Resolve in aid of the Maine General Hospital at Portland.

Maine general
hospital, Port-
land, in aid of.

Resolved, That there be appropriated and paid out of the state treasury, to the trustees of the Maine general hospital, the sum of ten thousand dollars, and that the governor is hereby authorized to draw his warrant on the state treasurer for the same.

Chapter 170.

Resolve in favor of the Maine Industrial School for Girls.

Maine industrial
school for girls,
in favor of.

Proviso.

Resolved, That the sum of four thousand nine hundred and thirty-four dollars be, and the same is hereby appropriated for the use of the Maine Industrial School for Girls, at Hallowell, to meet the current expenses of the ensuing year, the same to be expended by the trustees of said school; *provided*, the trustees will make to the governor and council a full and detailed report of the expenditure of the above appropriation.

Chapter 171.

Resolve in favor of W. N. Woodbury.

W. N. Woodbury,
in favor of.

Resolved, That when W. N. Woodbury shall have shown to the land agent that he is the actual owner of certificate of lot number

three, range one, in the east half of township number two, range five, and shall have paid to the land agent the sum of twenty-five dollars, the land agent be and is hereby authorized to convey, by deed, lot number three, range one, in the east half of township number two, range five, to the said W. N. Woodbury.

Chapter 172.

Resolve in favor of the Maine State College of Agriculture and the Mechanic Arts.

Resolved, That the sum of eight thousand dollars be and the same is hereby appropriated for the purpose of paying existing debts, for instruction and contingent expenses of the Maine State College of Agriculture and the Mechanic Arts, the same to be in full for any and all expenditures by the state on account of said college for the current year.

Chapter 173.

Resolve in favor of the State Centennial Commission.

Resolved, That the sum of ten thousand dollars be appropriated for the befitting exposition of Maine's resources at the forthcoming international exhibition at Philadelphia, to be expended, or so much thereof as shall be necessary, under the care and direction of the state centennial commission, subject to the approval of the governor and council.

Chapter 174.

Resolve to provide for the uniforming of the enlisted men of the Maine Volunteer Militia, and for other military purposes.

Resolved, That the sum of ten thousand dollars be and hereby is appropriated, to be expended as required by the provisions of section three, chapter twenty-nine, public laws of the year eighteen hundred and sixty-nine, or in the repair and modification of the uniforms and equipments now in use by the enlisted men of the Maine volunteer militia, and the necessary expenses of a
