Any other person prohibited from carrying passengers. Offence, how punished. SECT. 2. Any person who shall use or employ, on said lake, any boat or water eraft propelled by steam, as carrier of passengers, without being authorized by said corporator, his associates or assigns, shall forfeit for each offense not less than twenty dollars, and not exceeding one hundred dollars, to be recovered by and for the use of said corporator, his associates and assigns, in an action of debt.

Chapter 340.

An act to amend section one of chapter three hundred and fourteen, of the private and special laws of eighteen hundred and seventy-three, relating to legalizing the doings of the East Kennebee Agricultural and Horticultural Society.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :

Ch. 314, special laws 1873, amended. SECT. 1. Chapter three hundred and fourteen of the private and special laws of eighteen hundred and seventythree is hereby amended, by striking out the word "East," in the first line of said section, and inserting in place thereof the word 'Eastern,' so that the said section, when amended, shall read as follows:

Proceedings of Eastern Kennebec Ag. and Hort. Society legalized. 'SECT. 1. The acts and proceedings of said Eastern Kennebec Agricultural and Horticultural Society, at their annual meeting, held December thirty, eighteen hundred and seventy-one, are hereby ratified, legalized and confirmed.'

SECT. 2. This act shall take effect when approved.

Chapter 341.

An act to authorize the town of Yarmouth to build a foot bridge over tide waters.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

SECT. 1. The town of Yarmouth, in the county of Cumberland, is hereby authorized and empowered to construct and maintain a foot bridge, with a proper draw,

over and across tide waters separating Littlejohn's island CHAP. 342 from Cousin's island, in said town of Yarmouth.

SECT. 2. The powers of municipal officers of the town of Powers of muni-Yarmouth, relating to said bridge, shall be the same as are established by law, in regard to town and private ways.

This act shall take effect when approved. SECT. 3.

Chapter 342.

An act to amend the charter of the Camden Village Corporation.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

SECT. 1. Section two of "an act to incorporate the Act of 1867, sec. 2, amended. Camden Village Corporation," approved February fourteen, eighteen hundred and sixty-seven, as amended by act of eighteen hundred and seventy-six, is hereby further amended by adding thereto the following words: 'and for seating, and for apparatus for lighting and warming said village hall, the amount invested for that purpose not to exceed twelve hundred dollars, to be raised by assessment, or loan on a time not exceeding ten years, as the corporation may decide,' so that said section, as amended, shall read as follows :

' SECT. 2. Said corporation is hereby authorized and vested powers vested with power, at any legal meeting called for the purpose, to raise money to defray the expenses of a night watch, a police force, and all other necessary measures for the better security of life and property, and for the promotion of good order and quiet within its limits; for the purchase, repair and preservation of one or more fire engines, engine houses, hose, buckets, ladders, or other apparatus for the extinguishment of fires; for the construction of reservoirs and aqueducts to supply water; for organizing and maintaining, within the limits of said territory, an efficient fire department, and for building or assisting in building a village hall; the amount invested for that purpose not to exceed eight thousand dollars, to be raised by loan, instead of assessment, on a time not exceeding ten years, if said corporation shall so vote; and for seating, and for apparatus for lighting and -further powers.
