CHAP. 349

Chapter 349.

An act to amend chapter two hundred and sixty-three of the special laws of eighteen hundred and seventy-six, relating to the fishing interests in Lufkin pond.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :

Ch. 263, special laws of 1876, amended.

SECT. 1. The provisions of chapter two hundred and sixty-three of the special laws of eighteen hundred and seventy-six, are hereby amended, by adding thereto the following :

Penalty for taking fish.

‘And any person, excepting those owning said pond, who shall take from the same any fish during said time, shall be liable to a penalty of ten dollars for each fish taken, to be recovered by indictment, complaint or action of debt, one-half to the complainant, and the other half to the town of Phillips.’

SECT. 2. This act shall take effect when approved.

Chapter 350.

An act to authorize the city of Bath to appoint a Harbor Master for the Port of Bath, and establish regulations for the anchoring of vessels in said port.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :

City council of Bath authorized to make ordinances for location and regulation of vessels in that port.

SECT. 1. The city council of the city of Bath are hereby authorized to make such by-laws or ordinances as they may deem expedient, for the location and regulation of vessels in the port of Bath, and to impose penalties for breach of same, not exceeding ten dollars for one offense ; *provided*, said laws and ordinances shall not be repugnant to the general laws of the state.

Proviso.

Municipal authorities may appoint harbor masters.

SECT. 2. The municipal authorities of the city of Bath may appoint a harbor master for the port of Bath, who shall continue in office until a successor is qualified, and whose duty it shall be to enforce the observance of the by-laws or ordinances aforesaid, and to exercise such powers as may be conferred upon him by the ordinances of the city.
