Chapter 373.

CHAP. 373

An act to amend "an act to incorporate the People's Ferry Company," and to repeal "an act to establish the Sagadahoc Ferry Company," and "an act to incorporate the Union Ferry Company."

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :

SECT. 1. Chapter three hundred and sixty-four of the private and special laws of eighteen hundred and seventy-three is hereby repealed.

Ch. 364, special laws 1873, repealed.

SECT. 2. Section six of chapter one hundred and fifty-three of the private and special laws of eighteen hundred and seventy-two, repealed by the act hereby repealed, is hereby revived and declared to be in full force, and amended, so as to read as follows :

Sec. 6, ch. 163, special laws 1872, revived and amended.

'SECT. 6. That said corporation is hereby authorized and empowered to purchase of the proprietors of the Sagadahoc Ferry Company, and, upon written request being made by said proprietors, said corporation shall purchase all the property belonging to said company, at such sum as may be agreed upon by this corporation and said proprietors ; and in case of disagreement as to the price to be paid therefor, then the value thereof shall be determined by three disinterested persons, who shall be non-residents of either Bath or Woolwich, to be appointed as follows : one by the proprietors of the Sagadahoc ferry, one by the mayor of the city of Bath, and the two to select a third person who shall be a non-resident of either Bath or Woolwich. Both of the said parties shall accept such appraisal as may be awarded by said appraisers. All expenses attending said appraisal shall be paid equally by the parties thereto.'

Corporation may purchase property of Sagadahoc Ferry Company.

SECT. 3. The act of the legislature entitled, "an act to establish the Sagadahoc Ferry Company," approved March seven, eighteen hundred and thirty-four, and chapter one hundred and eighteen of the private and special laws of eighteen hundred and sixty-two, approved January thirteen, eighteen hundred and sixty-two, are hereby repealed.
