TOWN OF HAYNESVILLE .- BATH DRIVING PARK.

County taxes collected in eighteen hundred and seventy-six, nine thousand sixteen dollars and ninety-seven cents,

\$9,016 97

Amounting to eleven hundred ninety-nine thousand, eight hundred fifty-seven dollars and seventy-three cents, \$1,199,857 73 SECT. 2. This act shall take effect when approved.

### Chapter 385.

An act to change and fix the limits of the town of Haynesville.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

The limits of the town of Haynesville, as defined Limits of town of Haynesville, SECT. 1. by chapter two hundred and ninety-three of the special laws of eighteen hundred and seventy-six, are hereby so changed that the north line of said town shall be the north line of township number nine, Greenwood's survey, extended westerly to the east line of township number three, range three.

SECT. 2. All arrears of taxes which have been assessed Taxes, to whom within the limits of said town, as incorporated by the act aforesaid, shall be paid to the collector's of said town.

SECT. 3. Said town shall be entitled to the benefits of all Town entitled to stumpage, or timber cut since the act of incorporation of said town, on the reserved lands.

### Chapter 386.

An act to incorporate the Bath Driviug Park.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

### ANDROSCOGGIN POND AND DEAD RIVER.

CHAP. 387 Corporate name.

Powers and privileges.

Capital stock.

May hold real estate.

Purpose

Powers of police.

First meeting, how called. their associates, successors and assigns, are hereby created a body politic and corporate by the name of the Bath Driving Park, and by that name shall have power to sue and be sued, prosecute and defend all suits at law and in equity, and shall have all rights and privileges incident to such corporations, with right to adopt a common seal.

SECT. 2. The capital stock of said corporation may be fixed by the vote of the stockholders at an amount not to exceed thirty-five thousand dollars, and shall be divided into shares, the par value of which shall be twenty-five dollars per share.

SECT. 3. Said corporation shall have power to purchase and hold real estate in the county of Sagadahoc, or in Brunswick, in the county of Cumberland, the value of which, with improvements and betterments, shall not exceed twenty thousand dollars, and personal property not exceeding in value ten thousand dollars, for the purpose of constructing and maintaining a driving park, in order to aid in the improvement of the breed and value of horses in this state, and may adopt such rules, regulations and by-laws, as shall be deemed necessary, not repugnant to the laws of the state.

SECT. 4. All the powers and duties of the police of the city of Bath shall extend over such land as this corporation shall hold in Brunswick for the purpose herein named, concurrent with the police of Brunswick.

SECT. 5. The first meeting of corporators may be called by either of the corporators, by giving public notice in the Bath Daily Times, seven days before the meeting.

SECT. 6. This act shall take effect when approved.

### Chapter 387.

An act to authorize Samuel Cunningham to navigate Androscoggin pond and Dead river, by steam.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

SECT. 1. Samuel Cunningham, his associates and assigns, are hereby vested with the sole and exclusive right to navigate, by steam, the Androscoggin pond and Dead river, in
