BOARDING-HOUSE KEEPERS-ANDROSCOGGIN COUNTY.

Снар. 200 Unless otherwise ordered by some justice of the court, either in term time or vacation, one traverse jury only shall be in attendance for the trial of causes, and venires for jurors shall be issued by the clerk, in accordance with this section.

Chapter 200.

An Act concerning lunholders, Boarding-House Keepers and their Guests.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

SECT. 1. Whoever puts up at an inn, and without having an express agreement for credit, procures food, entertainment or accommodation without paying therefor, and with intent to keepers. defraud the owner or keeper of the inn out of the pay for the same; or, with intent to cheat or defraud such owner or keeper out of the pay therefor, obtains credit at an inn for such food, entertainment or accommodation by means of any false show of baggage or effects brought thereto; or with such intent, removes or causes to be removed any baggage or effects from an inn or boarding house, while there is a lien existing thereon for the proper charges due from him for fare and board furnished therein, shall be punished by imprisonment not exceeding three months, or by fine not exceeding fifty dollars.

Innholders shall post up a printed copy of sec- Printed copy of SECT. 2. tions one and two of this act, in a conspicuous place in each room of their inns.

Chapter 201.

An Act to fix the salaries of the County Commissioners of Androscoggin County.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :

Sect. 1. The pay of each county commissioner of Androscoggin county shall be two dollars and fifty cents for each day employed in the service of the county, and travel as now fixed by law.

SECT. 2. This act shall take effect when approved.
