Chapter 465.

An Act to incorporate the Lake Sebago Land Company.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Sect. 1. Payson Tucker, S. J. Anderson, Fred N. Dow, Benjamin F. Chadbourne, Tobias Lord, Junior, and W. F. Chadbourne, their associates, successors and assigns, are hereby incorporated by the name of Lake Sebago Land Company, for the purpose of buying, selling, leasing and improving real estate.

Corporate

-purposes.

Said corporation may for said purpose hold real SECT. 2. and personal estate, not exceeding in amount two hundred thousand dollars.

May hold real

SECT. 3. The capital stock of this corporation shall be one hundred thousand dollars, and shall be divided into shares of fifty dollars each. It may issue bonds to be secured by mortgage of all its property.

Capital stock.

SECT. 4. The first meeting may be called by a notice First meeting, signed by any two of the corporators, and mailed to the others at least seven days before the day fixed for such meeting.

SECT. 5. This act shall take effect when approved.

Chapter 466.

An Act for the protection of Pickerel in Little Schago Pond.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

No pickerel shall be taken from Little Sebago

Taking of pickerel from Little Sebago Windham and Little Sebago SECT. 1. pond or any of its tributaries, in the towns of Windham and Gray, in the county of Cumberland, with hook and line or in any other way, between the first day of October and the first hibited for five day of June following, in each year, for a term of five years, commencing October first, eighteen hundred and eighty-nine.
