**CHAP. 467**

Penalty for violation.

**SECT. 2.** Any person violating the provisions of this act, shall be liable to a fine not exceeding ten dollars for the first offense, and a further fine of one dollar for each fish so taken, to be recovered, on complaint, before any trial justice, police or municipal court in said county of Cumberland, one-half to the complainant and one-half to aforesaid county.

Approved February 28, 1889.

**Chapter 467.**

An Act to regulate the taking of fish from Potter's Pond, in the town of Carthage, in Franklin County.

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:*

Taking of fish from Potter's pond, prohibited between Oct. 1 and May 1.

**SECT. 1.** No fish of any kind shall be taken from Potter's pond and its tributaries, in the town of Carthage, in Franklin county, from the first day of October to the first day of May following, of each year.

Penalty for violation.

**SECT. 2.** Any person violating the provisions of this act shall forfeit the sum of ten dollars for each offense, and a further fine of one dollar for each fish so taken, to be recovered before any trial justice in Franklin county, one-half to the complainant, and one-half to the county of Franklin.

**SECT. 3.** This act shall take effect when approved.

**Chapter 468.**

An Act to authorize the Lewiston and Auburn Horse Railroad Company to make a loan.

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:*

Company authorized to issue bonds.

**SECT. 1.** The Lewiston and Auburn Horse Railroad Company is hereby authorized to issue its bonds, payable at such time and at such rate of interest as it may deem expedient, to an amount not exceeding twenty-five thousand dollars, in addition to those already issued by said corporation. The said loan to be made for the purpose of improving its road and equipment and making a further extension of its line of

track in Lewiston and Auburn, and for other purposes; and the said corporation is hereby authorized to mortgage its road, franchise and other property to secure the payment of such additional bonds.

SECT. 2. This act shall take effect when approved.

### Chapter 469.

An Act to prohibit the taking of Fish from Tuft's, Grindstone and Dutton Ponds, in Franklin County.

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :*

SECT. 1. All persons are prohibited from taking fish of any kind from Tuft's, Grindstone or Dutton ponds, or any of its tributaries, in the town of Kingfield, in Franklin county, between October first and May first following, of each year, for the term of five years.

Taking of fish from certain ponds in Franklin county, prohibited between Oct. 1 and May 1.

SECT. 2. Any person violating the provisions of this act shall be liable to a fine of five dollars for each fish so taken, to be recovered before any trial justice in said county, one-half to the complainant and one-half the county of Franklin.

Penalty for violation.

SECT. 3. This act shall take effect when approved.

### Chapter 470.

An Act to prohibit the taking of Fish from Long and Weeks' Ponds, and their tributaries, in the town of Parsonsfield, in York County.

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :*

SECT. 1. All persons are hereby prohibited from taking fish of any kind from Long pond and Weeks' pond, and their tributaries, in the town of Parsonsfield, in York county, for the term of five years.

Taking fish from Long and Weeks' ponds, prohibited for five years.

SECT. 2. Any person violating the provisions of this act, shall be liable to a fine not to exceed ten dollars, to be recovered on complaint before any trial justice in the county of York, one-half to the complainant, and one-half to the county of York.

Penalty for violation.

SECT. 3. This act shall take effect when approved.
