CHAP. 18

Resolve in favor of the Maine General Hospital.

Resolved, That there be and hereby is appropriated the sum of seven thousand five hundred dollars, to be paid to the Maine General Hospital for use of said institution for the year eighteen hundred and ninety-one, and seven thousand five hundred dollars for use of said institution for the year eighteen hundred and ninety-two.

Chapter 19.

Resolve in aid of the Children's Home in Bangor.

Resolved, That the sum of one thousand dollars be and is hereby appropriated for the Children's Home of Bangor for the year eighteen hundred and ninety-one, and the same amount for the year eighteen hundred and ninety-two.

Chapter 20.

Resolve in favor of John E. Kelley.

John E. Kelley,
in favor of.

Resolved, That the treasurer of state be directed to pay John E. Kelley, formerly sheriff of Lincoln county, the sum of seven hundred and nine dollars, being the balance of the damage which the said Kelley has suffered on account of a lien attachment of a vessel, made by him under the provis-

ious of the revised statutes of Maine, which provisions were subsequently held by the supreme court of Maine to be unconstitutional.

Resolve in favor of Swanville.

Resolved, That there be paid by the treasurer of state out of the school funds of the current year, to the town of Swanville the sum of twenty-nine dollars and eighty-nine cents, it being a balance equitably due said town as its proportion of the school funds for the year eighteen hundred and ninety.

Chapter 22.

Resolve in favor of helping maintain road from Patten to Crystal Plantation.

Resolved, That there be and hereby is appropriated four hundred dollars to aid in maintaining the road leading from Patten Village in a southerly direction across Crystal Plantation to Sherman. The same to be expended under the direction of the county commissioners of Aroostook county.

Chapter 23.

Resolve in favor of Macwahoe Plantation.

Resolved, That seven hundred and fifty dollars be appropriated for repairs of bridge across the Macwahoe Stream, the same to be expended under the direction of the county commissioners of Aroostook county.
