by her husband; or by the ward or person claiming under him, no such sale shall be avoided on account of any irregularity in the proceedings, if it appears;

I. That the license was granted by a court of competent jurisdiction, and that the deed was duly executed and recorded.

II. That the person licensed gave the bond and notice of the time and place of sale required by law.

III. That the premises were sold in such manner and within such time as the license authorized, and are held by one who purchased them in good faith.'

### Chapter 144.

An Act to increase the salary of the County Attorney for the County of Somerset

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:*

On and after the first day of January in the year of our Lord eighteen hundred and ninety-three, the salary of the county attorney for the county of Somerset, shall be five hundred dollars per annum instead of the sum now provided by law.

Salary of county attorney for Somerset county, increased.

### Chapter 145.

An Act to regulate the packing and sale of Domestic Sardines.

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:*

SECT. 1. Whoever bakes, fries, packs or cans any herring or other fish for sardines, without heading and eviscerating the same, and whoever sells, offers for sale or has in his possession for sale, any sardines packed without being so headed and eviscerated, shall forfeit twenty dollars for every one hundred cans so packed, sold, offered for sale, or in possession for sale, to be recovered by indictment or action of debt, one-half to the complainant, or prosecutor, and one-half to the town in which the offense is committed.

Packing, etc., of herring without heading and eviscerating the same, prohibited.

SECT. 2. This act shall not apply to any sardines already packed.
