## CHAP. 157

**Chapter 157.**

An Act to amend chapter eighty-six of the Revised Statutes, relating to  
Trustee Suits.

*Be it enacted by the Senate and House of Representatives  
in Legislature assembled, as follows:*

Sec. 4, ch. 86, R.  
S., amended.

When a partner-  
ship is made a  
trustee in trus-  
tee suit, service  
on one member,  
sufficient.

—proviso.

SECT. 1. Section four of chapter eighty-six of the revised statutes is hereby amended by adding at the end thereof, the following words: 'When a partnership is made a trustee in a trustee suit, service upon one member of the firm shall be a sufficient attachment of the property of the principal defendant in the possession of the firm, provided legal service shall be afterwards made upon the other members of the firm.'

Sec. 6, amended.

—when suit is  
discontinued,  
trustee shall not  
be entitled to  
cost.

—proviso.

SECT. 2. Section six of chapter eighty-six of the revised statutes is hereby amended by adding at the end thereof, the following words: 'When a trustee suit is discontinued or settled by the principal parties thereto before the return day of the writ, the trustee shall be entitled to no costs, provided the plaintiff or his attorney shall notify the trustee in writing before the return day of the writ, that the action has been discontinued.'

**Chapter 158.**

An Act to fix the salary of the County Attorney for the County of Lincoln.

*Be it enacted by the Senate and House of Representatives  
in Legislature assembled, as follows:*

Salary of county  
attorney,  
Lincoln county,  
fixed.

On and after the first day of January, in the year of our Lord one thousand eight hundred and ninety-three, the salary of the county attorney of Lincoln county shall be four hundred dollars per annum, instead of the sum now established by law.
