## CHAP. 400

**Chapter 400.**

An Act additional to an act, creating the Dover and Foxcroft Village Fire Company.

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :*

Dover and Foxcroft Village Fire Co., authorized to set off land within its limits.

SECT. 1. The Dover and Foxcroft Village Fire Company is hereby given authority to set off from the limits of said corporation any territory, land or residences within its limits, by a majority vote of the legal voters in said corporation, at any meeting legally called for that purpose, upon petition therefor.

SECT. 2. This act shall take effect when approved.

**Chapter 401.**

An Act authorizing the Governor and Council to execute a contract for lighting the State Prison.

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :*

Governor and council, authorized to contract for light and power for the state prison.

SECT. 1. That the governor and council are hereby authorized and instructed to execute a contract in behalf of the state of Maine with the Knox Gas and Electric Company for lighting the Maine State Prison, and all the buildings in Thomaston which belong to the state for a term of ten years, with not less than one hundred and twelve sixteen candle power incandescent lights or their equivalent, and to furnish such electrical power for the purposes of the prison as may be required, for the sum of twenty cents per one thousand watts, payable semi-annually on the first days of January and July in each year. Said term shall begin when light shall be furnished under the provisions of said contract. And said company is to introduce lights into said state prison and buildings on or before July first, in the year of our Lord eighteen hundred and ninety-three. Said contract shall provide that said company shall at its own expense wire said buildings, and at the expiration of the contract, if not renewed, the state shall pay

to said company the cost of such wiring less the depreciation thereof. CHAP. 402

SECT. 2. This act shall take effect when approved.

### Chapter 402.

An Act to amend chapter one hundred eleven of the Private and Special Laws of eighteen hundred and eighty-seven, entitled "An Act to incorporate the Dixfield and Peru Bridge Company."

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :*

SECT. 1. That section two of chapter one hundred eleven of the private and special laws of eighteen hundred and eighty-seven be amended by striking out in the fourth line the words, "twenty-four feet wide," and inserting in place thereof, the words, 'eighteen feet wide in the clear,' so that said section as amended, shall read as follows :

S. c. 2, ch. 111,  
Special Laws,  
1887, amended.

'SECT. 2. Said bridge shall be erected across the Androscoggin river within the limits aforesaid, shall be constructed of good materials, of a suitable height from the water, and not less than eighteen feet wide in the clear, with suitable and sufficient covering or railing for the safety of passengers, and sufficient passage way shall be left for the passage of boats, rafts, logs and timber.'

How bridge  
shall be con-  
structed.

SECT. 2. And said chapter shall be further amended by inserting immediately after section eight thereof, the following :

'SECT. 9. This corporation is authorized and empowered to mortgage its property and issue mortgage bonds to an amount not exceeding twenty thousand dollars.'

SECT. 3. This act shall take effect when approved.
