CHAP. 499

Chapter 499.

An Act authorizing the city of Saco to remove the bodies of persons deceased now interred in Pepperell Park, Saco.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :

Removal of dead bodies in Pepperell Park, Saco, authorized.

SECT. 1. The city of Saco in the county of York, is hereby authorized whenever its city council shall so vote to take such action as shall be deemed proper and expedient by said council for the disinterment, removal and care of the dead bodies now lying in Pepperell park, so called, in said Saco ; and in case such bodies are to be removed said city is likewise authorized to procure and purchase suitable lots in some cemetery or cemeteries for their interment, and attend to the proper resetting of any and all grave stones now standing in said Pepperell park and to do anything or things necessary to a proper and decent care of said bodies, and in case it is decided by said council not to remove such bodies, said city is hereby authorized upon a vote of said council therefor to so arrange that part of said park where said bodies now are, as may be deemed consistent and in harmony with the other arrangements of said park.

SECT. 2. Said city of Saco is hereby authorized to raise such sums of money by loan or taxation, as may be necessary to accomplish the purpose of this act.

SECT. 3. This act shall take effect when approved.

Chapter 500.

An Act to amend chapter two hundred and seventy of the Private and Special Laws of eighteen hundred and ninety-one, entitled, "An Act to amend chapter one hundred and seventy-nine, of the Private and Special Laws of eighteen hundred and sixty-seven, entitled, 'An Act for the protection of trout in Cathance Lake, Washington County.'"

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :

Taking of trout in Cathance lake, between September and April, prohibited.

The fifth line of chapter two hundred seventy of the private and special laws of eighteen hundred ninety-one is hereby amended by striking out the words "October" and "June" and inserting in their respective places, the words 'September' and 'April.'
