Chapter 544.

An Act amendatory of Chapter seventy of the Private Laws of eighteen hundred and eighty-one entitled "An Act additional to an act entitled 'An Act to incorporate the Sebois Dam Company,' approved February twenty-two, eighteen hundred and sixty-nine."

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

SECT. 1. Section one of chapter seventy of the private acts of eighteen hundred and eighty-one is hereby amended by inserting in the fifth line thereof after the words "so called" the words 'or which shall arrive at the place of manufacture,' and after the words "Penobscot boom" in the ninth line thereof the words 'or place of manufacture,' so that said section as amended, shall read as follows:

Sec. 1, ch. 70,
Private Laws,
1881, amended.

SECT. 1. Instead of the toll now provided, the said corporation may demand and receive a toll of forty cents for each thousand feet, board measure, woods scale, for all logs driven over their dam, erected or to be erected at or near the outlet of Trout lake, or Endless lake, so called, or which shall arrive at the place of manufacture, and said corporation shall have a lien on all such logs for the payment of said toll; and if said toll is not paid within ten days after said logs, or a major part thereof, shall have arrived at the Penobscot boom, or place of manufacture, the corporation may sell at public auction, in the city of Bangor, so many of said logs as may be necessary to pay said toll with incidental charges, first giving public notice of the time and place of sale in some daily newspaper published in Bangor, but the logs of each particular mark shall be holden only for the toll on such mark.'

SECT. 2. When the tolls received amount to a sum sufficient to pay all expenses of construction and repairs upon said dam, with interest at eight per cent per annum, the toll shall then cease.

SECT. 3. This act shall take effect when approved.
