**Chapter 151.**

Resolve in aid in rebuilding bridge in Hamlin Plantation.

*Resolved*, That there be and is hereby appropriated the sum of three hundred dollars, to be expended under the direction of an agent, to be appointed by the governor and council, in rebuilding the bridge across Bonny brook, so called, in Hamlin plantation, in Aroostook county.

**Chapter 152.**

Resolve in favor of the town of Moscow.

*Resolved*, That the sum of five hundred dollars be and is hereby appropriated to aid the town of Moscow in building a road.

**Chapter 153.**

Resolve in favor of Madawaska Training School.

*Resolved*, That for the erection of an addition to the school building of Madawaska Training School at Fort Kent, and for completing and properly equipping the boarding house erected for the benefit of said school, there be and hereby is appropriated the sum of four thousand dollars for the year eighteen hundred ninety-three, and the like sum of four thousand dollars for the year eighteen hundred ninety-four, the same to be expended under the direction of the board of trustees of State Normal Schools.

**Chapter 154.**

Resolve authorizing the County of Kennebec to procure a loan.

*Resolved*, That the treasurer of the county of Kennebec is authorized to procure by loan, on the faith and responsibility of said county, the sum of fifteen thousand dollars, exclusive

of and in addition to loans authorized by section seventeen of chapter seventy-eight of the revised statutes, for the purpose of funding the floating debt of said county, and the said treasurer is hereby authorized to issue bonds of said county with interest coupons attached, to the amount of such loan; said bonds to bear interest, payable semi-annually, at a rate not exceeding four per cent per annum, the principal to be payable at such times, not later than twenty years from the date thereof, as said commissioners may fix; said bonds to be signed by the treasurer and countersigned by the county commissioners of said county.

**Chapter 155.**

Resolve in favor of the Commissioners of Inland Fisheries and Game of moneys which lapsed into the treasury from the appropriation of eighteen hundred and ninety-two.

*Resolved*, That there be appropriated from the state treasury to be expended by the commissioners of inland fisheries and game under the direction of the governor and council, the sum of sixteen hundred and seventy-three dollars, for the purposes of that department and for none other.

**Chapter 156.**

Resolve in favor of the Town of Bradford.

*Resolved*, That there be paid by the treasurer of state, out of the school fund of the current year, to the town of Bradford, the sum of seventy-four dollars and fourteen cents, it being a balance equitably due said town as its proportion of the school funds for the year eighteen hundred and ninety-two.
