Jedediah Elliott, in favor of JEDEDIAH ELLIOTT-COPIES OF CERTAIN REPORTS.

### Chapter 219.

Resolve in favor of Jedediah Elliott of Baldwin.

Resolved, That there be paid out of the state treasury to Jedediah Elliott of Baldwin, the sum of four dollars per month as a military pension, commencing January first, one thousand eight hundred and ninety-three.

Approved March 2°, 1893.

#### Chapter 220.

Resolves fixing the number of copies of certain reports to be printed at the expense of the State.

Resolved, That the number of copies of the following reports to be printed hereafter at the expense of the state, shall be as follows: report of the secretary of agriculture, said reports to contain not over five hundred pages, ten thousand copies for the year eighteen hundred and ninety-three and twelve thousand for the year eighteen hundred and ninety-four; of insurance commissioner's report thirteen hundred copies for the year eighteen hundred and ninetythree and fifteen hundred for the year eighteen hundred and ninety-four; of railroad commissioner's report fifteen hundred copies for each of the years of eighteen hundred and ninetythree and eighteen hundred and ninety-four; of labor commissioner's report four thousand for the year eighteen hundred and ninety-three and five thousand for the year eighteen hundred and ninety-four; of the superintendent of schools four thousand to be issued biennially in December eighteen hundred and ninety-four; of the adjutant general one thousand to be issued biennially in December eighteen hundred and ninety-four; of treasurer of state two thousand and five hundred annually; of trustees and superintendent of insane hospital twenty-five hundred to be issued bienially in December eighteen hundred and ninety-four; of board of state assessors three thousand to be issued annually; of trustees and superintendent of reform school two thousand to be issued biennially in December eighteen hundred and ninetyfour; of attorney general fifteen hundred to be issued biennially in December eighteen hundred and ninety-four; of land agent one thousand to be issued biennially in December eighteen

hundred and ninety-four; of warden and inspectors of state CHAP. 221 prison fifteen hundred to be issued biennially in December, eighteen hundred and ninety-four; of commissioners of fisheries and game three thousand to be issued biennially in December eighteen hundred and ninety-four; of industrial school fifteen hundred to be issued biennially in December eighteen hundred and ninety-four; of the board of health six thousand to be issued biennially in December eighteen hundred and ninety-three; of state librarian one thousand to be issued biennially in December eighteen hundred and ninety-four; of trustees of the college of agriculture and mechanic arts fifteen hundred to be issued annually in the years eighteen hundred and ninety-three and eighteen hundred and ninety-four. The state librarian is hereby authorized to sell all the above reports to parties not entitled to them by custom or courtesy at cost. Of the above reports there shall be at least two hundred copies bound in cloth of each, delivered to the state librarian from the bindery for exchange and library use. Of the above reports three-fourths of them shall be stitched and bound in cloth, and one-fourth stitched and bound in paper in pamphlet form.

Resolved, That all acts and parts of acts, resolves and parts of resolves, inconsistent herewith, are hereby repealed.
