CHAP. 226**Chapter 226.**

Resolves authorizing a temporary loan for the year eighteen hundred and ninety-four.

Temporary
loan, authorized.

Resolved, That to provide for the wants of the treasury, the treasurer of state be, and is hereby authorized to procure on the faith of the state, if he shall deem it necessary, at any time during the year eighteen hundred and ninety-four, a temporary loan of three hundred thousand dollars or so much thereof as may be needed.

Resolved, That the treasurer of state be, and is hereby authorized to give notes in behalf of the state, payable within three years from the date hereof, for such portions of the loan hereby authorized as may be required.

Chapter 227.

Resolve authorizing the destruction of certain State of Maine bonds.

Preamble.

WHEREAS, the towns of Haynesville, Long Island, Mayfield and Trescott have forfeited their claim to any portion of the state of Maine bonds issued October one, eighteen hundred sixty-nine, under chapter two hundred twenty-five of the public laws of eighteen hundred sixty-eight, as amended by chapter forty of the public laws of eighteen hundred sixty-nine, and

WHEREAS, state of Maine bonds to the amount of one thousand two hundred dollars were held in the state treasury as the proportion of said bonds belonging to said towns under the act above referred to, and

Destruction of
state bonds, in
favor of.

WHEREAS, said bonds are still on hand in the state treasury; therefore be it

Resolved, That the committee first appointed by the governor and council after the passage of this act, to examine the accounts of the state treasurer, are hereby authorized and instructed to destroy by burning said state of Maine bonds, amounting to the par value of one thousand two hundred dollars, together with all coupons attached to same, and furnish certificate of such destruction as provided by section

seventy-one, chapter two of the revised statutes of eighteen hundred eighty-three.

Resolve in favor of Charles W. Weymouth.

Resolved, That the sum of fifty dollars be and hereby is appropriated to be paid out of the state treasury to Charles W. Weymouth, on account of extra services in connection with the elevator during the session of the legislature.

Chapter 229.

Resolve in favor of the Maine State Library.

Resolved, That there be appropriated for the purchase of historical, scientific and literary works for the Maine State Library, the sum of one thousand dollars for the year eighteen hundred and ninety-three, and one thousand dollars for the year eighteen hundred and ninety-four; for the purchase of Maine reports and acts and resolves, five hundred dollars; for the purchase of law reports to complete sets in the library, two thousand dollars; for completing the cataloguing of books, eight hundred twenty-five dollars; for clerk hire for the year eighteen hundred ninety-three, five hundred dollars; for clerk hire for the year eighteen hundred ninety-four, five hundred dollars.
