KATAHDIN PULP AND PAPER COMPANY.

committee of four, to be elected on the third Monday of CHAP. March, annually, or as soon as may be thereafter by the city council, by a majority of all the members by roll call. The said committee shall hold office till the third Monday in March following their election, and until their successors are chosen and qualified.'

SECT. 2. This act shall take effect when approved.

Chapter 67.

An Act to authorize the Katahdin Pnlp and Paper Company to locate, construct and maintain piers and booms in Penobscot river,

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

SECT. 1. Authority is hereby given to the Katahdin Pulp and Paper Company, a corporation duly established by law, and having its place of business at Lincoln, in the county of Penobscot Penobscot, to locate, construct and maintain in the Penobscot river, in the town of Lincoln, piers and booms for the purpose of collecting and holding logs and pulp wood for the mill of said company; said piers and booms to be between a line drawn across Penobscot river at the foot of Mattanawcook island, and a line drawn across said river at the outlet of Cambolasse stream; said piers and booms to be so located, constructed and maintained that neither they nor the lumber in them, shall interfere with the navigation of said river for -shall not logs and lumber, or the free passage of boats between any of navigation. the landings of the Indians on the islands in said river, between said Lincoln and the town of Chester, except the small grass island near the east shore of said river and above the foot of the Indian road, so called, in Lincoln, nor the free passage of the water craft of the Indians between any and all of said landings on Mattanawcook island and the foot of said Indian road.

SECT. 2. Said company shall, so far as it can, prevent the logs of other parties getting into any of its booms, but if stray logs from entering logs of other parties, in any considerable quantities, should hooms, so far as it can. get into any of the booms of said company, said company shall take them out of such boom by the time the rear of the

68 drive in which said logs shall come, shall reach the foot of said boom, if possible; in all other cases the company shalk be entitled to a reasonable time for the taking of stray logs out of any of their booms and delivering the same to the owners after demand for such delivery shall be made upon it.

Chapter 68.

An Act to divide the town of Peru in the county of Oxford, and annex a portion of said town of Peru to the town of Rumford in the county of Oxford.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

county of Oxford, which is located northwesterly of the following boundaries, namely: Commencing on the westerly bank of the Androscoggin river, in said town of Peru, at the easterly corner of lot numbered twenty-nine, thence by the

southeasterly line of lots numbered twenty-nine, twentyeight, twenty-seven, twenty-six, twenty-five and in a direct course across lot number twenty-four, which course shall be a prolongation of said line to a point on the division line between the town of Peru and Franklin plantation where said line prolonged shall intersect said town line, thence northerly by the line dividing Peru from said Franklin plantation to the town line of Rumford, thence by the lines dividing the towns of Rumford and Mexico from Peru to the place of beginning, together with the inhabitants thereof, is set off

Taxes due, shall be paid to town of Peru. from the town of Peru and annexed to the town of Rumford. SECT. 2. The several inhabitants of the town of Peru, on the territory hereby annexed to the town of Rumford, shall be holden to pay all taxes which have been legally assessed upon them by the town of Peru, and the collector of taxes for the town of Peru is hereby authorized and required to collect and pay all taxes already committed to him, under his respective warrants, to the town of Peru.

SECT. 3. Said town of Peru shall pay all its debts and liabilities now existing, upon contract or otherwise, or which may hereafter arise in consequence of any acts or causes of action now existing, including the state and county tax now
