Chapter 182.

An Act for the better protection of fish in Long Pond, Mount Desert Island.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :

SECT. 1. All persons are hereby prohibited from fishing for or taking trout, land-locked salmon, or smelts from Long pond in the towns of Tremont and Mount Desert, in the county of Hancock, from the first day of October in each year, to the first day of May following, for a period of four years.

Taking of trout, etc., from Long pond, prohibited for four years.

SECT. 2. Any person who shall violate the provisions of this act shall be punished by a fine of five dollars for each offense and a further penalty of one dollar for each fish taken, to be recovered on complaint before any trial justice in said county, one-half to the complainant and one-half to the said county of Hancock.

—penalty for violation.

Approved March 14, 1895.

Chapter 183.

An Act for the protection of fish in Sweet's Pond, Clear Water Pond, and North or Varnum's Pond and their tributaries, in Franklin County.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :

SECT. 1. All persons are prohibited from fishing for, or taking fish of any kind from Sweet's pond, situated partially or wholly in the town of New Vineyard; Clear Water pond, situated in the towns of Industry and Farmington; and North or Varnum's pond, situated in the towns of Temple and Wilton, in Franklin county, between the first day of October and the first day of May following of each year for five years.

Taking of fish in certain ponds in Franklin Co., prohibited for five years.

SECT. 2. All persons are prohibited from fishing for, or taking fish of any kind from any of the tributaries of either of said ponds, for the term of five years.

Fishing in tributaries, prohibited.

SECT. 3. Any person violating the provisions of this act shall be liable to a fine of ten dollars, and a further fine of one dollar for each fish so taken, to be recovered on complaint before any trial justice or municipal court in the county of Franklin, or on indictment, one-half to the complainant and one-half to aforesaid county.

—penalty.

Approved March 14, 1895.
