**Chapter 197.**

An Act to prohibit the taking of trout from Marble Brook and Marble Pond in Blanchard for the term of four years.

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :*

SECT. 1. No person shall take, catch, fish for, kill or destroy any trout or land-locked salmon, in Marble brook or Marble pond situated in Blanchard, Piscataquis county, Maine, at any time within four years from the approval of this act.

Taking of fish, in Marble brook or pond, prohibited for four years.

SECT. 2. Any person who shall violate the provisions of this act, shall pay a fine of five dollars and shall further pay the sum of one dollar for each and every trout and land-locked salmon so taken, caught, killed or destroyed, to be recovered by complaint before any trial justice or municipal court, one-half to the complainant, and one-half to the county where the complaint is made.

**Chapter 198.**

An Act to prohibit the taking of certain fish in streams which flow into Anonymous Pond in the town of Harrison, Cumberland County.

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :*

SECT. 1. All persons are hereby prohibited from fishing for, catching, killing or destroying any fish, suckers excepted, in any of the streams that flow directly or indirectly into Anonymous pond in the town of Harrison in the county of Cumberland, for a term of four years.

Taking fish from Anonymous pond, prohibited for four years.

SECT. 2. All persons violating the provisions of this act shall be subject to a fine of ten dollars for the offense, and one dollar additional for each and every fish taken, killed or destroyed. The fines and penalties to be enforced in accordance with the provisions of law applicable to the general fish and game laws.
