CHAP. 213**Chapter 213.**

An Act to authorize Simeon G. Davis, his associates and assigns, to construct and maintain a wharf and boat house in Lake Maranocook, in the town of Winthrop.

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :*

S. G. Davis,  
authorized to  
construct a  
wharf.

Simeon G. Davis, his associates and assigns, are hereby authorized and empowered to construct, maintain and control a wharf extending into the waters of lake Maranocook, in the town of Winthrop, not exceeding seventy-five feet, and to construct, maintain and control a boat house over or in said waters of such dimensions as he or they shall deem proper, both to be located at or near the outlet of said lake ; provided, they shall first obtain the consent of the owners of the shores of the lake to which said wharf and boat house are adjacent, or the consent of the municipal officers of said town in case said wharf or boat house are adjacent to any highway or town way.

**Chapter 214.**

An Act to change the spelling of the name of the town of Waterborough.

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :*

SECT. 1. The name of the town Waterborough, in the county of York, is hereby changed to Waterboro.

SECT. 2. This act shall take effect when approved.

**Chapter 215.**

An Act to change the name of the Spring Street Baptist Society of Auburn.

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :*

SECT. 1. The society hitherto called and known by the name of the Spring Street Baptist Society of Auburn, shall henceforth be called and known by the name of the Court Street Baptist Society.

SECT. 2. This act shall take effect when approved.
