Chapter 48.

Resolve in favor of the city of Old Town.

City of Old
Town, in
favor of.

Resolved, That the sum of two hundred and nineteen dollars and sixty-four cents, being a balance in equity due to the city of Old Town as its proportion of the school funds for the year one thousand eight hundred and ninety-three, be paid to said city by the treasurer of the state of Maine out of the school funds of the current year.

Chapter 49.

Resolve making appropriations for the Passamaquoddy Tribe of Indians.

Resolved, That there be paid from the state treasury, to be expended under the direction of the governor and council to the agent of the Passamaquoddy tribe of Indians, for the benefit of said tribe, for the years one thousand eight hundred and ninety-five and one thousand eight hundred and ninety-six as follows: for May dividend four hundred dollars each year; for November dividend four hundred dollars each year; for distressed and contingent poor, three thousand five hundred dollars each year; for contingent purposes, one hundred and fifty dollars each year; for bounty on crops, two hundred dollars each year; for ploughing, one hundred and fifty dollars each year; for salary of governor, one hundred dollars each year; for salary of lieutenant governor, forty dollars each year; for wood, six hundred and fifty dollars each year; for dressing for land, one hundred and fifty dollars each year; for educational purposes, eight hundred dollars each year; for salary of priests, two hundred dollars each year; for salary of agent, two hundred dollars each year; for basket ash, three hundred and fifty dollars each year; for agricultural purposes, six hundred dollars each year; for police, twenty dollars each year; repairs of Sister's Home at Point, one hundred dollars in one thousand eight hundred and ninety-five; repair of road at Point, one hundred dollars in one thousand eight hundred and ninety-six; school books each year, thirty dollars.

All the foregoing sums to be expended under the direction of the governor and council for the purposes for which they

are appropriated, and for none other, and any sum of money not expended for the purposes for which it is appropriated shall not be allowed to said agent in the settlement of his account. CHAP. 50

Chapter 50.

Resolve in favor of the Maine State Library, for the years eighteen hundred ninety-five and eighteen hundred ninety-six.

Resolved, That the sum of four thousand dollars be and is hereby appropriated for the use of the Maine State Library for the year eighteen hundred and ninety-five, and that a like sum be and is hereby appropriated for the year eighteen hundred ninety-six, the same to be expended yearly for the following purposes; for completing sets of American laws, statutes, digests and law reports, twelve hundred dollars. For completing English law reports, two thousand dollars. For employment, labor, packing books and documents, cataloguing, typewriting and preparing general index to acts and resolves, eighteen hundred twenty to eighteen hundred ninety-five, eight hundred dollars.

Chapter 51.

Resolve in favor of the Plantation of Lexington.

Resolved, That the state treasurer be directed to pay to the treasurer of the plantation of Lexington the sum of four hundred and five dollars and nineteen cents, being its part of the school and mill fund tax of the years one thousand eight hundred and ninety-one and one thousand eight hundred and ninety-two and county tax for said years.
