### Chapter 388.

An Act to extend the rights and powers of the corporation organized December sixteen, eighteen hundred and ninety-two, under the Revised Statutes of Maine, chapter fifty-five, as the Bangor General Hospital, and now named Eastern Maine General Hospital.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Sect. 1. The organization of said corporation as now existing, is hereby ratified, confirmed and made valid.

Sect. 2. The change of name to Eastern Maine General Hospital is hereby ratified, confirmed and made valid, but all name confirmed. gifts, bequests or devises under either name shall be valid and binding, and the trustees shall have the power to cause proper transfers and conveyances to be made in order to place title in the proper name.

Sect. 3. In addition to the trustees elected by the corporation, there shall be three trustees chosen by the board of vis- provided for. itors, hereinafter provided for, and said board shall have sole power of removal of, and of filling vacancies among said three trustees.

Additional

Sect. 4. Said corporation may receive and hold property and estate to any amount, whether real, personal or mixed, whether now owned by it or which may hereafter be purchased by, or given, granted, bequeathed or devised to it for hospital purposes, and by it thus accepted.

Corporation may hold property.

Sect. 5. This act shall take effect when approved.

Approved March 3, 1897.

#### Chapter 389.

An Act to amend Chapter two hundred and ninety-eight of the Private and Special Laws of eighteen hundred and eighty, entitled "An Act to incorporate the Canton Bridge Company."

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Sect. I. To amend section two of said act by striking out in the fourth line of said section the words "twenty-four," and inserting instead the word 'twenty,' so that said section shall read as follows:

Charter. Canton Bridge Company, amended.
