**Chapter 204.**

An Act to amend Section four of Chapter ninety-one of the Revised Statutes, relating to Notice of Foreclosure on a mortgage of Personal Property.

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:*

Section four of chapter ninety-one of the revised statutes is hereby amended by inserting in the fifth line thereof after the word "mortgagor" the following words 'cannot be found by reasonable diligence or,' so that said section as amended, shall read as follows:

Section 4 of chapter 91, R. S., amended.

'Section 4. The mortgagee or his assignee, after condition broken, may give to the mortgagor or his assignee, when his assignment is recorded where the mortgage is recorded, written notice of his intention to foreclose the same, by leaving a copy thereof with the mortgagor or such assignee, or if the mortgagor cannot be found by reasonable diligence or is out of the state, although resident therein, by leaving such copy at his last and usual place of abode, or by publishing it once a week, for three successive weeks in one of the principal newspapers published in the town where the mortgage is recorded. When the mortgagor or his assignee of record is not a resident of the state and no newspaper is published in such town, such notice may be published in any newspaper printed in the county where the mortgage is recorded.'

Notice of foreclosure, how to be given and served.

**Chapter 205.**

An Act to increase and fix the salary of the Assistant Librarian.

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:*

Section 1. The state librarian shall appoint one assistant who shall perform the duties prescribed by him, and shall give bond to the librarian for the faithful performance of the same. The assistant librarian shall receive a salary of twelve hundred dollars, per year, beginning January one, nineteen hundred and three, in full for all of his services of every name and nature.

Salary of assistant librarian.

Section 2. All acts or parts of acts inconsistent with this act, are hereby repealed. This act shall take effect when approved.
