#### Снар. 34

### Chapter 34.

An Act to extend the powers of the Katahdin Pulp and Paper Company.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Katahdin Pulp and Paper Company, powers increased.

—may manufacture and deal in Inmher.

—may generate electricity and other power.

Section I. The Katahdin Pulp and Paper Company, a corporation organized under the general laws of the state, in addition to the powers which it already possesses, is hereby authorized and empowered to manufacture lumber of all kinds; to buy, sell and otherwise deal in the manufactured products of lumber; to carry on lumber operations in the woods, and to supply others carrying on such operations; and to buy and sell logs and other Said company is also authorized and empowered to generate and create electricity and other power for manufacturing and other purposes within the town of Lincoln, in the county of Penobscot, and to lease or sell the same, also to supply the inhabitants of said town, or any village corporation within said town, with water, lights and heat for domestic, sanitary and municipal purposes, including the extinguishment of fires, and generally to do all things necessary and convenient for carrying on the business of the company, including the carrying on of a general mercantile business in connection with any of the purposes of the company.

Doings made

Section 2. The acts and doings of the stockholders and directors of said company in building and equipping its saw mill at said Lincoln, are hereby ratified, confirmed and made valid. Section 3. This act shall take effect when approved.

#### Chapter 35.

An Act to authorize the State Land Agent to convey to the Fish River Railroad Company, rights of way over public lots owned by the state.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Section I. The state land agent is hereby authorized, empowered and directed, when thereto requested by the Fish River Railroad Company to execute to said railroad company, for a nominal consideration on behalf of the state, a deed of right of way, six rods wide, over such public lots owned by the state as are crossed by the railroad of said company; the center line of said six rods to be the center line of the location of said railroad.

Section 2. This act shall take effect when approved.
