the right to prosecute actions at law and in equity, and adopt a seal and code of by-laws not inconsistent with the laws of the state.

Section 4. Vacancies by death, resignation or otherwise shall be filled by said Huntoon Hill Grange from the membership thereof.

Section 5. Any two persons named in this act, may call the first meeting of this corporation, by written notice, delivered or mailed each corporator, at least five days before the time of said meeting.

Section 6. This act shall take effect when approved.

Chapter 150.

An Act to amend the charter of the President and Trustees of Colby College.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Section 1. That section three of the act entitled "An Act to establish a Literary Institution in the District of Maine, within this commonwealth," passed by the general court of Massachusetts and approved February twenty-seven, eighteen hundred thirteen, and from time to time amended, be further amended by inserting after the word "trustees" in the eleventh line thereof the following words; 'except as hereinafter provided,' and by adding to the end of said section the following words: 'And provided also that nine of the trustees shall be elected by the Alumni association of Colby college, to be known as Alumni Trustees and to be elected, three each year, for terms of three years, in such manner as said association may provide.' So that said section three as amended, shall read as follows:

'Section 3. Be it further enacted, that for the more orderly conducting the business of the said corporation, the president and trustees shall have full power and authority, from time to time as they shall determine, to elect a vice president, treasurer and secretary of said corporation, and to declare the tenure and duties of their respective offices, and also to remove any trustee from the said corporation, when in their judgment he shall be rendered incapable by age or other ways, of discharging the duties of his office, and to fill up all vacancies in the said corporation, by electing such persons for trustees, except as hereinafter provided, as they shall judge best: Provided nevertheless,

that the number of the said corporation, including the president of the said institution, and the treasurer for the time being, shall never be greater than thirty-one, nor less than twenty-one: And provided also, that nine of the trustees shall be elected by the Alumni association of Colby college to be known as Alumni Trustees and to be elected, three each year, for terms of three years, in such manner as said association may provide.'

Section 2. The first three of the trustees herein provided for shall, for their first term, be elected during the year nineteen hundred four, the second three during the year nineteen hundred five and the third three during the year nineteen hundred six.

Section 3. This act shall take effect when approved.

Chapter 151.

An Act to amend An Act entitled "An Act to authorize the opening of a second channel of Mousam River."

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Section 1 of chapter 92 of special laws of 1887, amended.

Section one of chapter ninety-two of the private and special laws of eighteen hundred eighty-seven is hereby amended by striking out all words after the word "river" in the ninth line of said section, and inserting in place thereof the following: 'and should it prove necessary for the economical execution of above purpose, they are authorized to build dams or other artificial obstructions required,' so that said section as amended, shall read as follows:

Corporators.

'Section 1. Hartley Lord, Robert W. Lord, Owen Wentworth, Emery Andrews and Sidney T. Fuller, together with such persons as they shall associate with themselves, their heirs and assigns, are hereby authorized and empowered to cut a channel from any point below Clay Hill bridge, so called, in Mousam river, so called, in Kennebunk, through the lands of Owen Wentworth and others, to the Cove, so called, which lies easterly of Gillespie's point, so that sail and row boats may pass to and from said cove into said river, and should it prove necessary for the economical execution of above purpose, they are authorized to build dams or other artificial obstructions of any kind required.'
