—powers and duties of water commissioners.

three years. Said commissioners are authorized to fix the water rates and determine the conditions and manner of the water supply, and shall have the general control and management of the water system owned by the town. The above commissioners, with such additional commissioners as the town may, from time to time, elect, shall apply the surplus funds arising from said system solely for the purpose of the liquidation of the water works loan. They shall receive such compensation for their services as may be fixed by the town.'

Section 2. This act shall take effect when approved.

Chapter 225.

An Act relating to the powers of the Portland and Rumford Falls Railway.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Section I. The Portland and Rumford Falls Railway is hereby authorized and empowered to guarantee the payment, both principal and interest, or either, of the bonds of other railroad corporations, upon such terms as said corporations may mutually agree.

Portland and Rumford Falls Ry. empowered to guarantee payment of bonds of other railroads.

Section 2. The Portland and Rumford Falls Railway is hereby authorized and empowered to lease the Rumford Falls and Rangeley Lakes Railway and any other railroad that may connect with the latter railroad on such terms as may be mutually agreed upon.

Authorized to lease Rumford Falls and Rangeley Lakes Ry.

Section 3. This act shall take effect when approved.

Chapter 226.

An Act to authorize Frederick J. Merrill of Damariscotta to construct a tide wheel in tide waters of the Damariscotta River.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Section 1. Frederick J. Merrill is hereby authorized to build and maintain a tide wheel in the tide waters of the Damariscotta river, and within the limits herein described, as follows:

Beginning on the east shore of said Damariscotta river, on the land of said Frederick J. Merrill, at low water mark, thence

Frederick J. Merrill authorized to maintain a tide wheel in Damariscotta river. Снар. 227

running northwesterly forty feet, and of width sufficient to successfully run and operate said wheel, provided said wheel shall not obstruct navigation.

Section 2. This act shall take effect when approved.

Chapter 227.

An Act to incorporate the Rangeley Trust Company of Rangeley, Maine.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Corporators.

Section 1. H. A. Furbish, James B. Dill, F. E. Timberlake and N. P. Noble or such of them as may by vote accept this charter, their associates, successors and assigns, are hereby made a body corporate and politic to be known as the Rangeley Trust Company, and as such shall be possessed of all the powers, privileges and immunities and subject to all the duties and obligations conferred on corporations by law.

Location.

Section 2. The corporation hereby created shall be located at Rangeley, in the county of Franklin and state of Maine.

Purposes.

Section 3. The purposes of said corporation and the business which it may perform are; first, to receive on deposit, money, coin, bank notes, evidences of debt, accounts of individuals, companies, corporations, municipalities and states, allowing interest thereon, if agreed, or as the by-laws of said corporation may provide; second, to borrow money, to loan money on credits, or real estate, or personal security, and to negotiate loans and sales for others; third, to own and maintain safe deposit vaults, with boxes, safes and other facilities therein, to be rented to other parties for the safe keeping of moneys, securities, stocks, jewelry, plate, valuable papers and documents, and other property susceptible of being deposited therein, and may receive on deposit for safe keeping, property of any kind entrusted to it for that purpose; fourth, to act as agent for issuing, registering and countersigning certificates, bonds, stocks, and all evidences of debt or ownership in property; fifth, to hold by grant, assignment, transfer, devise or bequest, any real or personal property or trusts duly created, and to execute trusts of every description; sixth, to act as assignee, receiver or executor, and no surety shall be necessary upon the bond of the corporation, unless the court or officer approving the same shall require it; seventh, to do in general all the business that may be lawfully done by trust and
