Chapter 359.

An Act to authorize the Town of York to construct and maintain Sewers in said town.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Town of York authorized to maintain sewers.

Section 1. The town of York is hereby authorized to construct and maintain a system or systems of sewers within said town in such places and such manner as may be determined by the inhabitants of said town at any legal town meeting, and to make appropriations necessary therefor.

Authorized to lay pipes, etc.

Section 2. Said town is authorized, for the purposes aforesaid, to construct, lay down and maintain all such pipes or other structures as may be necessary for properly conducting, discharging and disposing of sewerage; and to excavate in and through any land in said town when necessary for the purpose aforesaid.

May cross tide waters.

Section 3. Said town is authorized to lay, extend and maintain its pipes into, under and across tidal waters, and to build and maintain all structures necessary therefor, but in such manner as not to obstruct navigation.

May cross railroads.

Section 4. Said town is authorized to lay, construct and maintain in, through, under and along any railroads and water courses in said town all pipes and other structures necessary or convenient for the purposes herein set forth, and to take up, replace and repair the same when necessary. Provided, that in case of crossing any railroad at any point outside the limits of any highway, unless said town of York shall agree with the corporation, person or persons owning and operating such railroad, as to place, manner and conditions of such crossings, the railroad commissioners shall determine the place, manner and conditions thereof; and all work within the limits of the location of such railroad shall be done under the supervision and to the satisfaction of the officials of such railroad, but at the expense of said town.

-proviso.

Rights, powers and privileges.

Section 5. To carry out the purposes aforesaid said town of York is hereby granted all the rights, powers and privileges which towns, and their municipal officers, have under the first sixteen sections of chapter sixteen of the revised statutes, as amended, and under chapter two hundred and eighty-five of the public laws of eighteen hundred eighty-nine, relating to drains and sewers.

Section 6. This act shall take effect when approved.
