**Chapter 22.**

Resolves in relation to the completion of the fifth revision of the general and public laws, and appointing a Commissioner therefor.

Revision of  
public laws,  
in relation to.

*Resolved*, That John A. Morrill, of Auburn, be appointed a commissioner to complete the revision of the general and public laws of the state, incorporating the public laws of the present session, and to complete the index of the same, correcting the notes and marginal annotations of sections to correspond with the final draft of the revision; preparing marginal notes and references for new sections; adding references to all appropriate cases reported in the ninety-sixth volume of Maine reports and subsequent volumes and to all decisions interpreting the constitution of the United States and of the state of Maine which appear in the one hundred eighty-third volume of the reports of the supreme court of the United States and subsequent volumes; and carefully to superintend the printing of said revision and index, with such additions as may be made under the provisions of these resolves.

*Resolved*, That the foregoing work be performed by said commissioner under the supervision of Forrest Goodwin, George C. Wing, Howard Pierce, Beecher Putnam, Artemus Weatherbee, Henry W. Oakes, John W. Manson, Lincoln H. Newcomb, Natt T. Abbott and S. S. Thornton, members of the joint select committee of the present legislature on the revision of the statutes, who are hereby constituted a commission to sit during the recess of the legislature for that purpose, and to continue the work of said committee of the legislature for the completion of their work and the perfection of the revision.

*Resolved*, That the governor and council are hereby authorized to audit and cause to be paid, the services and expenses of said Morrill and said commissioners and of such clerks and other assistants as it may be necessary for said Morrill or said commissioners or committee to employ.

*Resolved*, That if said Morrill declines said duty, or becomes unable to perform it, the governor and council shall appoint some other suitable person to fill the vacancy, and do the duties herein prescribed for said Morrill.
