CHAP. 103

regulations, of both civil and criminal nature, and provide punishment for the violation thereof, as, in its judgment, may be necessary for the management, control and protection of such lands as may from time to time be acquired by the United States under the provisions of this joint resolution; provided, that the state of Maine shall retain a concurrent jurisdiction with the United States in and over such lands so far that civil process in all cases, and such criminal process as may issue under the authority of the state against any person charged with the commission of crime without or within said jurisdiction, may be executed thereon in like manner as if this joint resolution had not been passed.

That the senators and representatives in Congress from this state are hereby requested to urge upon Congress the importance of prompt and favorable action on behalf of the proposition to establish a White Mountain national forest reserve.

Chapter 103.

Resolve in favor of A. A. Burleigh, Chairman of the Committee on Interior Waters.

A. A. Burleigh,
in favor of.

Resolved, That there be paid from the state treasury to A. A. Burleigh, chairman of the committee on interior waters, the sum of one hundred and eighty-seven dollars and sixty-six cents for expenses incurred by him on behalf of the committee, for reports of evidence and arguments in connection with hearing on Millinocket bill.

Chapter 104.

Resolve in favor of Lee Normal Academy.

Lee Normal
Academy, in
favor of.

Resolved, That the sum of one thousand dollars is hereby annually appropriated out of the school fund, for the term of two years, to Lee Normal Academy, an institution of learning located in the town of Lee, in the county of Penobscot; provided, however, that this appropriation is made on the express conditions that the trustees of said institution shall maintain and keep in operation a school equal in rank and grade of teaching with a first-class academy, and in which shall be given special and systematic instruction in the science and art of teaching;

that no part of this appropriation shall be devoted to other purposes than the payment of instructors in said institution; that the superintendent of public schools shall be, ex-officio, a member of the board of directors thereof; and that if, in the opinion of the governor and council, said institution at any time hereafter shall fail to fulfill the conditions contained in this resolve, they may, in their discretion, withhold the appropriation herein granted; and provided further, that said normal academy shall not be entitled to any aid from the state for the years nineteen hundred and three and nineteen hundred and four in addition to that carried by this resolve.

Chapter 105.

Resolve in favor of the Eastern Maine Insane Hospital.

Resolved, That the sum of thirty thousand four hundred and twenty-five dollars be and is hereby appropriated for and in behalf of the Eastern Maine Insane Hospital, at Bangor, for the year nineteen hundred and three, and thirty thousand four hundred and twenty-five dollars for said institution, for the year nineteen hundred and four, for the purpose of meeting current expenses and making repairs and improvements, said sums to be expended under the direction of the trustees of insane hospitals.

Chapter 106.

Resolve in favor of the town of East Livermore.

Resolved, That the state treasurer be and is hereby authorized and directed to pay to the town of East Livermore the sum of fourteen hundred and ninety-seven dollars and seventy-six cents, the same being to reimburse said town for expenses incurred in the relief of George W. Wing and his family, state paupers, the same to be paid when said claim shall be allowed by the governor and council: Provided also that said sum be accepted in full settlement of the claim of said town for state paupers to December thirty-one, eighteen hundred and ninety-nine.
