20 CHAP.

Inhabitants of certain towns authorized for lighting.

Section 2. The inhabitants of the towns of Winter Harbor and Gouldsboro are hereby authorized to contract with said company for lighting said towns for such time and upon such terms as they may by vote or authority of the selectmen determine.

Section 3. The Winter Harbor Company, a corporation winter established and existing under the laws of said state, is hereby authorized and empowered to become a stockholder in the stock in. Winter Harbor Gas and Light Company with all the privileges, rights, powers and liabilities of stockholders.

Section 4. The act shall take effect when approved.

Chapter 20.

An Act to amend Chapter one hundred and fifty-four of the Private and Special Laws of eighteen hundred and ninety-five, as amended by Chapter two hundred and thirty-nine of the Private and Special Laws of nineteen hundred and one, relating to the charter of the Wiscasset Water Company.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Section nine of chapter one hundred and fifty-four of the private and special laws of eighteen hundred and ninety-five as amended by chapter two hundred and thirty-nine of the private and special laws of 1895, as amended by and special laws of nineteen hundred and one, is hereby amended as follows; the word "eight" in the first line of said section, as special laws of 1901 amended, is stricken out and the word 'ten' inserted so that said further section shall read as follows:

Section 9, private and chapter 239 private and amended.

'Section 9. This act shall become null and void in ten years This act void from the approval thereof, unless the corporation shall have from in ten years organized and commenced the actual construction of its works under this charter.'

Chapter 21.

An Act relating to fishing in the tributaries of Webb's River, above Goodwin Brothers' mill dam in Carthage, county of Franklin.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Section I. It shall be lawful to fish as provided in the gen- Webh's river eral law for fishing in all of the tributaries to Webb's river, fishing in. above Goodwin Brothers' mill dam in Carthage, in the county of Franklin.

Section 2. All acts and parts of acts, inconsistent with this act, are hereby repealed.
