**Chapter 29.**

An Act to amend section five of chapter two hundred and three of the private and special laws of eighteen hundred and eighty-three entitled "An Act to incorporate the Portland Trust Company."

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:*

Section 1. Section five of chapter two hundred and three of the private and special laws of eighteen hundred and eighty-three is hereby amended in the first sentence thereof by striking out the words "fifteen trustees" and inserting in place thereof the following words, namely, 'Not less than fifteen nor more than thirty trustees, as may be determined at each annual meeting,' so that said first sentence as amended shall read as follows, namely:

Section 5, chapter 203, special laws, 1883, amended.

'All the corporate powers of said corporation shall be exercised by a board of not less than fifteen nor more than thirty trustees, as may be determined at each annual meeting, and such officers and agents as they shall appoint.'

Board of trustees.

Section 2. This act shall take effect when approved.

**Chapter 30.**

An Act to authorize a bridge in the town of Edgecomb.

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:*

Section 1. The town of Edgecomb in the county of Lincoln and state of Maine is hereby authorized to erect and maintain a free bridge in substantially the place and manner the same is now constructed across a cove on the easterly side of the Sheepscot river in said Edgecomb, between upland belonging to John P. Chase formerly belonging to Norris and Gay and upland belonging to Caroline P. Trask, as a part of a town road laid out by the selectmen of the said town of Edgecomb, May four, nineteen hundred and three, and accepted by said town May thirteen, nineteen hundred and three.

Authorized to erect and maintain a free bridge.

Section 2. Said bridge originally constructed in the year nineteen hundred and four is hereby made and constituted a legal, proper, authorized and valid bridge, to all intents and purposes as though this act had been passed prior to the construction thereof.

Original bridge made legal and valid.

Section 3. This act shall take effect when approved.
