**Chapter 92.**

An Act to set off a part of Hamlin Plantation and annex the same to the town of Van Buren.

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:*

Part of  
Hamlin  
plantation  
annexed to  
Van Buren.

Section 1. So much of township G, in the second range of townships west from the east line of the state, as is included within the limits of lots numbered three hundred four and three hundred five and a ten-rod strip from the northwesterly side of lot numbered three hundred and six; which lots are situated partly in townships M and L, range two, and G, range one, west from the east line of the state, is hereby set off from Hamlin plantation and made a part of the town of Van Buren.

Section 2. This act shall take effect when approved.

**Chapter 93.**

An Act to prohibit the sale of Trout in Hancock County.

*Be it enacted by the Senate and House of Representatives in Legislature assembled as follows:*

Sale of  
trout in  
Hancock  
county  
prohibited.

Section 1. It shall be unlawful to fish for, take, catch or kill any trout in any of the waters lying wholly or partly in the county of Hancock for sale, and it shall likewise be unlawful to sell or offer for sale, directly or indirectly, any trout in said Hancock county, and it shall likewise be unlawful to take, catch, kill or have in possession in any one day more than twenty-five pounds of black bass from any of the waters lying wholly or partly in the towns of Eden, Mount Desert, Tremont, Hancock, Sullivan, Franklin, Eastbrook, Waltham and townships number seven, number ten, and number twenty-one, in the county of Hancock.

Section 2. Whoever shall violate any of the provisions of this act shall be subject to a penalty of not less than ten dollars nor more than thirty dollars for each offense and one dollar additional for every fish, caught, had in possession or sold in violation of the provisions of this act.

Section 3. That part of section three of the private and special laws of nineteen hundred and three, chapter four hundred and seven, denominated 'Hancock County' is hereby repealed.
