CHAP. 170**Chapter 170.**

An Act to regulate fishing in B Pond, in Upton, in the County of Oxford.

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:*

Fishing in  
B pond  
regulated.

Section 1. It shall be unlawful to fish for, take, catch or kill any kind of fish at any time in B pond, so called, in Upton, in the county of Oxford, except in the ordinary manner of casting with artificial flies or fly fishing.

Penalty for  
violation of  
this act.

Section 2. Whoever violates any of the provisions of this act shall be subject to a penalty of not less than ten dollars nor more than thirty dollars and costs for each offense and a further penalty of one dollar for each fish taken, caught, killed or had in possession in violation of the provisions of this act.

Proviso.

Section 3. Provided, further, that this act shall not take effect until the commissioners of inland fisheries and game, without expense to the state, have caused notices to be posted in conspicuous places at or near the waters herein described setting forth in substance the provisions of this act.

**Chapter 171.**

An Act to regulate fishing in the tributaries to Chemo Pond, in the County of Penobscot.

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:*

Fishing in  
Chemo pond  
and tribu-  
taries,  
regulated.

Section 1. It shall be unlawful to fish for, take, catch or kill any kind of fish at any time in any of the tributaries to Chemo pond, in the county for a distance of one mile up the stream from the mouth of each tributary. Provided that, without expense to the state, the mile point on each stream shall be plainly marked with a proper notice.

Penalty for  
violation of  
this act.

Section 2. Whoever violates any of the provisions of this act shall be subject to a penalty of not less than ten dollars nor more than thirty dollars for each offense and a further penalty of one dollar for each fish taken, caught, killed or had in possession in violation of the provisions of this act.
