**Chapter 318.**

An Act to extend the charter of the Old Town Trust Company.

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:*

Section 1. The rights, powers and privileges of the Old Town Trust Company, which were granted by chapter two hundred and forty-seven of the private and special laws of nineteen hundred and five, are hereby extended for two years from the approval of this act; and the persons named in said act, their associates and successors, shall have all the rights, powers and privileges that were granted them by said act, to be exercised in the same manner and for the same purpose as specified in said act.

Charter extended.

Section 2. This act shall take effect when approved.

**Chapter 319.**

An Act to amend and extend the charter rights, powers and purposes of the Sebec Power Company as authorized by Chapter two hundred nine of the Private and Special Laws of the state of Maine for the year nineteen hundred five.

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:*

Section 1. The Sebec Power Company shall have power and authority to acquire by purchase, lease, merger or consolidation, all the properties, rights, privileges and franchises of the Milo Electric Light and Power Company, a corporation organized under the general laws of the state of Maine, and having its principal place of business at Milo in said state upon such terms and conditions as may be agreed upon by the stockholders of said companies and subject to the provisions of sections fifty-six to sixty-seven inclusive, of chapter forty-seven of the revised statutes and subject also to the rights of all creditors of each of said companies, and said Milo Electric Light and Power Company is hereby authorized and empowered to lease or sell and convey its property, rights, privileges and franchises to the Sebec Power Company, or to merge or consolidate with said Sebec Power Company.

Authorized to acquire property of Milo Electric Light and Power Co.

Section 2. The Sebec Power Company is hereby authorized and empowered to acquire by purchase, lease, merger, consolidation, or otherwise, the property, rights, privileges and franchises of any other company engaged in selling and distributing electricity for lighting purposes in the county of Piscataquis whose lines as constructed or chartered would form connecting or continuing lines with lines of the Sebec Power Company, which by

chapter two hundred and nine of the private and special laws for the year nineteen hundred and five, it is authorized to construct and maintain, upon such terms and conditions as may be agreed upon by the stockholders of such other companies, and subject to the provisions of sections fifty-six to sixty-seven inclusive of chapter forty-seven of the revised statutes, and subject also to the rights of all the creditors of each and all of said companies, and each and all of said companies are hereby authorized and empowered to lease or sell and convey their respective properties, rights, privileges and franchises to the Sebec Power Company, or to merge or consolidate with said Sebec Power Company.

Rights,

Section 3. The Sebec Power Company shall have, possess and enjoy all the rights, powers, privileges and franchises specified in its certificate of organization, and those granted by the provisions of chapter two hundred nine of the private and special laws of the state of Maine approved March fifteenth, nineteen hundred and five, all of which are hereby confirmed and extended, subject to the provisions of chapter one of the revised statutes for the year nineteen hundred and three, and also upon the purchase or acquisition of the properties, rights and privileges of the Milo Electric Power Company, and the other companies specified in section two of this act or any of them, shall have, possess and enjoy all the powers, rights, privileges and franchises specified in the charters, or held, possessed or enjoyed by said several companies so purchased or acquired, and shall also have, possess and enjoy all the powers of a corporation formed under the provisions of chapter forty-seven of the revised statutes of the state of Maine.

May issue  
bonds.

Section 4. The Sebec Power Company is hereby authorized and empowered to issue its bonds for the purpose of providing means with which to pay for the properties, rights and privileges which it is hereby authorized to acquire, and the debts of the several companies, the property, rights, privileges and franchises of which it may acquire under the authority herein and hereby conferred, or to improve or add to its properties, and raise such funds as may be required in the conducting of its business, and secure the same by mortgage upon all or any of its property, franchises, rights and privileges.

Charter,  
how  
construed.

Section 5. The charter of the Sebec Power Company shall not be construed to give it a right to maintain any dam across Sebec river which shall injure or damage any water power now owned by the Sebec Dam Company or Addie A. Appleyard on Sebec river.

Section 6. This act shall take effect when approved.
