**Chapter 374.**

An Act to regulate fishing in Loon Lake and in Cow Pond, so called, in the County of Franklin.

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:*

Section 1. It shall be unlawful to fish for, take, catch or kill any kind of fish at any time in Loon lake or in Cow pond, so called, in the county of Franklin, except by the ordinary manner of casting with artificial flies or by trolling, so called.

Fishing in Loon lake and Cow pond, regulated.

Section 2. It shall be unlawful for any person, or the occupants of one boat, to take, kill or have in possession more than five pounds of trout or landlocked salmon in all, or one fish taken from Loon lake or from Cow pond, so called, in the county of Franklin, in one day.

Unlawful to take more than five pounds.

Section 3. Whoever violates any of the provisions of this act shall be subject to a penalty of not less than ten dollars nor more than thirty dollars for each offense and one dollar additional for each fish taken, caught or had in possession in violation hereof.

Penalty for violation of this act.

Section 4. Provided, further, that this act shall not take effect until the commissioners of inland fisheries and game, without expense to the state, shall have caused notices to this effect to be posted along the banks of the waters affected by this law.

Notices shall be posted.

Approved March 22, 1907.

**Chapter 375.**

An Act to regulate fishing in Bonneg Beg Pond, in Sanford and North Berwick, in the County of York.

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:*

Section 1. It shall be unlawful to fish for, take, catch or kill any trout or white perch in Bonneg Beg pond, in Sanford and North Berwick, at any time for a period of three years.

Close time for fishing in Bonneg Beg pond.

Section 2. Whoever violates any of the provisions of this act shall be subject to the same penalty as is provided in the general law of the state for illegal fishing.

Penalty for violation of this act.

Approved March 22, 1907.
