CHAP. 388

**Chapter 388.**

An Act to amend Chapter one hundred ninety-three of the Private and Special Laws of nineteen hundred three entitled, "An Act to incorporate the East Branch Improvement Company."

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:*

Section 3,  
chapter 193,

Section 1. Section three of chapter one hundred ninety-three of the private and special laws of nineteen hundred three entitled, "An Act to incorporate the East Branch Improvement Company," approved March eighteenth, nineteen hundred three, is hereby amended by inserting after the word "fifty-two" in the tenth line of said section the words 'and also to purchase and hold the stock of all or any one of the above mentioned companies or any other company or companies authorized to do a similar business, and to exercise all the rights incident thereto,' so that said section as amended, shall read as follows:

'Section 3. Said company is hereby authorized and empowered to take and hold by virtue of any conveyances made to it, the franchises, real estate, canals, sluiceways, piers, dams, wing dams, side dams, booms, steamboats, improvements, and other property of the Telos Canal Company and the Grand Lake Dam Company, both of which were incorporated by special acts of the legislature of Maine, approved August seven, eighteen hundred forty-six, and of the East Branch Dam Company, incorporated by special act of the legislature of Maine, approved April twenty-six, eighteen hundred fifty-two, and also to purchase and hold the stock of all or any one of the above mentioned companies or any other company or companies authorized to do a similar business, and to exercise all the rights incident thereto, which said companies are hereby authorized and empowered to sell, assign and convey by deeds duly executed by the presidents of the several companies, to said East Branch Improvement Company such franchises, real estate, canals, sluiceways, piers, dams, wing dams, side dams, booms, steamboats, improvements, and other property owned or possessed by them at the time of such transfer, and upon receiving such conveyances said East Branch Improvement Company is hereby authorized and empowered to exercise all the powers and privileges of said Telos Canal Company, said Grand Lake Dam Company and said East Branch Dam Company, including the assessment and collection of tolls in accordance with all acts of the legislature relating thereto, and the duties of the said several companies shall be and become the duties of said East Branch Improvement Company, which said company shall thereafter be holden to perform such duties.'
