o'clock in the afternoon, and from seven until nine o'clock in the afternoon on each of the five secular days next prior to the tenth day of August of each year for the purpose of making additions to said lists and changes and corrections in the party designation of voters. And thereafter said board of registration shall from time to time add to said list all names which have been added to the list of voters, with the party designation, if any, and shall take from said list all names which have been stricken from the list of voters.'

Section 2. After the board of registration shall have made the list of voters for the year nineteen hundred and seven with the party designation as provided in section three of said act, such party designation shall remain the same on that list and the lists for subsequent years unless a voter in person or in writing signed by him, shall request his party designation to be changed.

Section 3. This act shall take effect when approved.

408. Chapter

An Act to amend the Charter of the Twin Village Water Company.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Section I. Section two of chapter six hundred and seven of the private and special laws of eighteen hundred and ninetythree is hereby amended by inserting after the word "Newcastle" in the fourth line of said section, the word 'Bristol' so that said section when amended, shall read as follows:

'Section 2. The business to be carried on by said corporation shall be to furnish water for the extinguishment of fires and for domestic, sanitary and municipal uses to the towns of Nobleboro, Newcastle, Bristol and Damariscotta, and the inhabitants thereof, and to furnish electric lights for lighting streets in said towns, and to dispose of electric light and power to individuals and corporations."

Section 2. Section six of said chapter is hereby amended by inserting the word 'Bristol' before the word "and" in the fourth line of said section so that said section when amended, shall read as follows:

'Section 6. Said corporation is hereby authorized to lay down pipes and to set poles and extend wires, in and through the streets and ways in said towns of Nobleboro, Newcastle,

—liable for damages caused by use of streets. Bristol and Damariscotta, and to take up, replace and repair all such pipes, aqueducts, poles and fixtures as may be necessary for the purposes of their incorporation under such reasonable restrictions as may be imposed by the selectmen of said towns, and all provisions of this act relating to the construction, repairs, maintaining or operating works for furnishing electric light or power, shall be subject to the provisions of chapter three hundred and seventy-eight of the public laws of eighteen hundred and eighty-five. And said corporation shall be responsible for all damages to persons and property occasioned by the use of such streets and ways, and shall further be liable to pay to said towns all sums recovered against said towns for damages from obstruction caused by said corporation, and for all expenses, including reasonable counsel fees incurred in defending such suits, with interest on the same.'

Section 7, amended.

May make contracts for supplying water and light.

-towns may contract for water and light and exempt from taxation, Section 3. Section seven of said chapter is hereby amended by inserting the word 'Bristol' before the word "and" in the second line of said section so that said section when amended, shall read as follows:

'Section 7. Said corporation is hereby authorized to make contracts with said towns of Nobleboro, Newcastle, Bristol and Damariscotta, with any village corporations that now or hereafter may exist in said towns or either of them, and with other corporations and individuals for the purpose of supplying water or electric light or power, as contemplated by this act; and said towns by their selectmen, and said village corporations by their assessors, are hereby authorized to enter into contracts with said company for the supply of water and electric lights or power, and for such exemption from public burden as said towns and such corporations and said company agree upon, which, when made, shall be legal and binding upon all parties thereto.'

Section 4. This act shall take effect when approved.
