CHAP. 418**Chapter 418.**

An Act to prevent the hauling of heavy teams on the highways of Brooklin from the fifteenth of March to the tenth of May.

Hauling of heavy terms on highways regulated.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Section 1. It shall be unlawful for any person or party to haul a load by more than one yoke of oxen or one pair of horses as a team upon the highways of the town of Brooklin in the county of Hancock between the fifteenth day of March and the tenth day of May of each year, except by a written permit signed by the three municipal officers.

Penalty for violation.

Section 2. Whoever shall violate section one of this act shall on conviction of the same be punished by a fine of not less than ten nor more than twenty-five dollars for each and every offense.

Section 3. This act shall take effect when approved.

Chapter 419.

An Act to amend Chapter two hundred sixty-seven of the Private and Special Laws of nineteen hundred and five in relation to Alfred Light and Power Company, and to legalize its issue of Bonds.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Trust deed of Alfred Light and Power Co. ratified.

Section 1. The trust deed of Alfred Light and Power Company to Knickerbocker Trust Company dated July first, in the year of our Lord one thousand nine hundred and five, and the issue of bonds secured thereby is hereby ratified, confirmed and made valid.

Section 2, amended.

Section 2. Section two of said act is hereby amended by striking out the whole of said section and substituting the following:

Purposes.

'Section 2. The purposes of said corporation are the making, generating, selling, distributing and supplying electricity, for manufacturing, mechanical, power and light purposes to Sanford Mills, Goodall Worsted Company, Maine Alpaca Company and Atlantic Shore Line Railway, corporations existing under the laws of the state of Maine and located in Sanford, York county, Maine, with all the rights, privileges and powers, and subject to all the restrictions and liabilities by law incident to corporations of a similar nature.'

Section 5 repealed.

Section 3. Section five of said act is hereby repealed.

Section 4. This act shall take effect when approved.

Approved March 26, 1907.
