Resolve in favor of the Farmington State Normal School.

*Resolved*, That there be and hereby is appropriated the sum of forty-five hundred dollars for the year nineteen hundred and seven and twenty-five hundred dollars for the year nineteen hundred and eight to be paid to the Farmington State Normal School, for repairs, furniture and books.

**Chapter 111.**

Resolve for the purpose of erecting a Fish Hatchery in Somerset County.

*Resolved*, That the sum of three thousand dollars is hereby appropriated for the year nineteen hundred and seven, also three thousand dollars for the year nineteen hundred and eight for the purpose of erecting a suitable fish hatchery, for the artificial propagation of fish to restock the waters of Somerset county, at some point in Somerset county, to be hereinafter determined by the commissioners of inland fisheries and game, and at such place as they shall determine.
