**Chapter 114.**

Resolve in aid of erecting a building at Van Buren College for college purposes.

*Resolved*, That the sum of fifteen thousand dollars be and the same is hereby appropriated to be paid to the president and trustees of Van Buren college, seven thousand five hundred on the first day of September, nineteen hundred and seven, and the sum of seven thousand five hundred dollars on the first day of September, nineteen hundred and eight, for the purpose of aiding in the erection of a building for college purposes at Van Buren college in the town of Van Buren, said building when completed to cost not less than forty-five thousand dollars.

**Chapter 115.**

Resolve in favor of Juno F. Curtis of Bingham.

*Resolved*, That the sum of one thousand dollars be and is hereby appropriated to be paid to Juno F. Curtis of Bingham to make up in part for her loss as the owner of the ferry at Bingham, caused by the building of the bridge between Bingham and Concord.

**Chapter 116.**

Resolve in favor of Limerick Academy.

*Resolved*, That there be and hereby is appropriated to be paid Limerick Academy for the use and benefit of that institution for the year nineteen hundred and six the sum of five hundred dollars.

**Chapter 117.**

Resolve in favor of navigation on Schoodic Grand Lake.

*Resolved*, That the sum of two hundred dollars is hereby appropriated for placing and maintaining buoys, and in aid of navigation in Schoodic Grand lake in Aroostook county. All of said money to be expended under the direction of the state steamboat inspectors.
