**Chapter 219.**

Resolve providing for the screening of Medomak pond or lake, so called, in Washington, in the County of Knox.

*Resolved,* That the sum of one hundred and fifty dollars be and is hereby appropriated for the purpose of screening Medomak pond or lake, so called, in Washington, in the county of Knox, to be expended under the direction of the commissioners of inland fisheries and game, when the balance necessary to erect said screen, as found by the commissioners, shall have been raised by the citizens of the county of Knox and paid into the treasurer of state for this purpose.

Medomak pond, to provide for screening of.

Provided, further, that this appropriation shall not be available until the town of Washington shall have, in legal town meeting, and having an article in the warrant for said town meeting for that purpose, by vote of record, voted to assume all liability for the keeping of said screen at all times free from sticks, leaves and all debris, so that the same will not become clogged and prevent the free running of the water through the same.

**Chapter 220.**

Resolve in favor of Walter J. Mayo, secretary for the Committee on Military Affairs.

*Resolved,* That the state treasurer be authorized to pay to Walter J. Mayo, secretary for the committee on military affairs, the sum of twenty dollars, same being the amount paid out for expenses of the committee.

**Chapter 221.**

Resolve in favor of Witnesses, Officers and Counsel in the matter of the hearing upon the Harry J. Chapman Resolve.

*Resolved,* That the sum of two thousand dollars be appropriated with which to pay witnesses who attended the hearing on the above resolve before the joint convention; to pay the fees of officers for summoning the same; and to pay counsel for the state and the respondent for their services and expenses in said matter, and the stenographer who was in attendance to take the proceedings of the convention.

Witnesses, officers and counsel in Harry J. Chapman hearing, in favor of.

CHAP. 222

Counsel for both parties shall present an account for their services and expenses, and also shall certify the names of witnesses and officers and the amounts due each, the same to be presented to the governor and council, who shall audit the same and draw a warrant for payment thereof upon the treasurer of the state.

Resolve in favor of C. W. Perry, Secretary to Committee on Mercantile Affairs and Insurance.

C. W. Perry,  
in favor of. *Resolved,* That the sum of thirty-five dollars be paid C. W. Perry for services of clerk and typewriter to the committee on mercantile affairs and insurance.

**Chapter 223.**

Resolve in favor of H. M. Sewall, chairman of Committee on gubernatorial Votes.

H. M. Sewall,  
in favor of. *Resolved,* That there be appropriated and paid to H. M. Sewall, chairman of the committee on gubernatorial votes, the sum of twelve dollars, for disbursements made for expenses in canvassing the votes returned for governor.

**Chapter 224.**

Resolve in favor of Clerk and Stenographer to the Joint Special Committee on Salaries and Fees.

W. S. Cotton,  
in favor of. *Resolved,* That there be appropriated and paid to W. S. Cotton one hundred sixty-three dollars and sixteen cents for services as clerk to the joint special committee on salaries and fees. Also for stenographer to said committee.
