Chapter 43.

An Act to amend Section three, Chapter forty-eight of the Revised Statutes, relating to the powers of Savings Banks.

Be it enacted by the People of the State of Maine, as follows:

Paragraph
five, section
3, chapter
48, R. S.,
amended.

Paragraph five of section three, chapter forty-eight of the revised statutes is hereby amended by inserting between the words "same" and "and" in the first line thereof, the words, 'to own, maintain and let safe deposit boxes and vaults,' and by adding to said section the following words: 'But no savings bank shall be liable for any loss of property deposited in said boxes or vaults for safe-keeping, beyond the sum paid for the rental thereof for the term within which such loss is discovered,' so that said paragraph as amended shall read as follows:

Powers and
liability.

'V. To receive money on deposit, to invest the same, to own, maintain and let safe deposit boxes and vaults, and further to transact the business of a savings bank, as hereinafter provided. But no savings bank shall be liable for any loss of property deposited in said boxes or vaults for safe-keeping, beyond the sum paid for the rental thereof for the term within which such loss is discovered.'

Approved March 3, 1909.

Chapter 44.

An Act to establish an additional Normal School to be located at Machias in the county of Washington.

Be it enacted by the People of the State of Maine, as follows:

Normal
school
established.

Section 1. Another normal school to be known as Washington State Normal School is hereby created and established upon such plans as the board of trustees for normal schools may direct.

Location
of school.

Section 2. Said normal school shall be located at Machias in the county of Washington, provided and upon condition that the inhabitants of said town of Machias, shall, within six months after the date of the approval of this act, to donate and cause to be conveyed to the state for the purpose and use of such school a lot of land not less than five acres in extent and whatever buildings stand thereon may be selected and approved by the said board of trustees for normal schools.

Said inhabitants of said town of Machias at a legal meeting of said inhabitants called and held within six months, are hereby authorized and empowered by a majority vote of the legal voters voting at said meeting to authorize and direct the
