'Section 20. No person shall can lobsters less than four and threee-fourths inches in length, alive or dead, measured in accordance with section seventeen of chapter forty-one of the canned, he measured. revised statutes, as amended by chapter forty-nine of the public laws of nineteen hundred and seven; and for every lobster canned contrary to the provisions of this section, every person, firm, association or corporation so canning shall be liable to a penalty of one dollar for every lobster so canned contrary to the provisions of this section, and a further penalty of three hundred dollars for every day on which such unlawful canning is carried on.

Chapter 66.

An Act authorizing towns and cities to elect Fish Wardens in certain cases

Be it enacted by the People of the State of Maine, as follows:

Any city, town or plantation in which there is a lake or a pond that has been stocked with fish by the state and screened partly by the state and partly by the town or by private subscription, may, at its annual election, elect a fish warden, with all the powers of other fish wardens, whose duty it shall be to care for and protect said screen.

Chapter 67.

An Act to amend Section seventeen of Chapter forty-one of the Revised Statutes of nineteen hundred and three as amended by Chapter fortynine of the Public Laws of nineteen hundred and seven, relating to Sea and Shore Fisheries.

Be it enacted by the People of the State of Maine, as follows:

Section seventeen of chapter forty-one of the revised statutes of nineteen hundred and three as amended chapter forty-nine of the public laws of nineteen hundred and seven is hereby further amended by inserting after the word "be" in the eighth line the word 'immediately;' by inserting ther amended. after the word "ships" in the fifteenth line the words 'transports, carries;' by striking out after the word "so" in the eighteenth line the words "bought, sold, given away, exposed for sale or shipped" and inserting in place thereof the words 'shipped, transported, carried, bought, given away, sold or
