exceeding six per cent a year, payable annually or semi-annually, to an amount which, including that of bonds previously issued, unless to be retired by the new issue, shall not exceed in all the capital stock of the corporation actually paid in at the time.'

### Chapter 102.

An Act to encourage the teaching of Manual Training, Domestic Science and Agriculture in Academies and to repeal Chapter seventy-eight of the Public Laws of one thousand nine hundred and seven.

*Be it enacted by the People of the State of Maine, as follows:*

Section 1. Any incorporated academy in the state maintaining a course in manual training, domestic science or agriculture, approved by the state superintendent of schools, shall be entitled to receive annually from the state, in addition to the state aid, if any, now provided by law, and to be paid in the same manner, a sum equal to the amount expended by said academy for instruction in such course, not exceeding two hundred and fifty dollars for each of said courses.

State aid for maintaining course in manual training, domestic science or agriculture.

Section 2. Chapter seventy-eight of the public laws of one thousand nine hundred and seven is hereby repealed.

Chapter 78, public laws, 1907, repealed.

### Chapter 103.

An Act to amend Section one hundred and thirteen of Chapter fifteen of the Revised Statutes, as amended by Chapter eleven of the Public Laws of nineteen hundred and five, relating to the number of Trustees of State Normal Schools.

*Be it enacted by the People of the State of Maine, as follows:*

Section 1. Section one hundred and thirteen of chapter fifteen of the revised statutes, as amended by chapter eleven of the public laws of nineteen hundred and five, is hereby further amended by substituting for the word "eight" in the second line of said section as amended, the word 'nine' and by substituting for the word "six" also in the second line of said section as so amended the word 'seven,' so that said section as amended shall read as follows:

Section 113, chapter 15, R. S., as amended by chapter 11, public laws, 1905, further amended.

'Section 113. Said schools are under the direction of a board of nine trustees, seven of whom shall be appointed by the governor with the advice and consent of the council, for not

Trustees of normal schools, appointment of, and number.
