Chapter 12.

An Act to amend Chapter fifty-five of the Private and Special Laws of Maine for the year nineteen hundred and three, incorporating the Squirrel Island Village Corporation.

Be it enacted by the People of the State of Maine, as follows:

Section five of chapter fifty-five of the private and special laws of Maine for the year nineteen hundred and three is hereby amended by striking out in the fourth line of said section the word "sixty" and inserting in place thereof the word 'seventy-five,' so that said section as amended shall read as follows:

'Section 5. The town of Southport shall annually pay over Taxes. to the treasurer of said corporation out of the taxes collected from the inhabitants and estates on Squirrel Island a sum equal to seventy-five per centum of all the town taxes, exclusive of the state and county tax, collected from said inhabitants and estates.

Chapter 13.

An Act to extend the charter of the Mattagamon Manufacturing Company. Be it enacted by the People of the State of Maine, as follows:

The rights, powers and privileges of the Mattagamon Manufacturing Company which were granted by chapter two extended. hundred and seventy-nine of the private and special laws of nineteen hundred and one and by chapter forty-seven of the private and special laws of nineteen hundred three and by chapter ninety-nine of the private and special laws of nineteen hundred five and by chapter twenty-eight of the private and special laws of nineteen hundred seven are hereby extended, and the persons named in said act, their associates, successors and assigns, shall have all the rights, powers and privileges that were granted them by said acts, to be exercised in the same manner and for the same purposes as specified in said acts.

Chapter 14.

An Act to amend the Charter of the Maine and New Brunswick Electrical Power Company, Limited.

Be it enacted by the People of the State of Maine, as follows:

Section 1. The Maine and New Brunswick Electrical Power Charter Company, Limited, subject to all the terms and provisions of amended.

chapter two hundred and forty-nine of the private and special laws of nineteen hundred and five entitled, "An Act to authorize the Maine and New Brunswick Electrical Power Company, Limited, of New Brunswick, to exercise certain powers in this state," is hereby authorized to extend its lines from its main line in Bridgewater to the boundary line between Maine and the province of New Brunswick and to transmit electricity over and from said main line and said extension for use for light, heat and power in said town of Bridgewater and for the lines of said company in the province of New Brunswick under its charter.

Municipal officers to locate streets, roads or ways to be occupied.

Section 2. All locations upon streets, roads or ways, in said town of Bridgewater, necessary for the purposes of this act, are hereby granted, and the municipal officers of said town shall designate the streets, roads or ways so to be occupied, the places where the poles shall be set, and shall establish such reasonable restrictions as to the kind of poles, their construction and maintenance, the height of wires and the use of guard wires, as they deem proper.

Special act not required. Section 3. Nothing in this act shall require any corporation organized under the general laws of the state for the sale and distribution of electricity in said town of Bridgewater to obtain any special act of the legislature therefor.

Chapter 15.

An Act to provide for ice fishing in Round pond, in the town of Greenwood, Oxford county.

Be it enacted by the People of the State of Maine, as follows:

Fishing through ice permitted. So much of section one of chapter four hundred and seven of the private and special laws of nineteen hundred and three as prohibits fishing through the ice as provided in the general law of the state, in Round pond, in the town of Greenwood, Oxford county, from February first of each year until the ice is out of said pond the following spring, is hereby repealed.

Chapter 16.

An Act authorizing the Union Construction Company to hold stock and bonds of other corporations.

Be it enacted by the People of the State of Maine, as follows:
