him laid before the county commissioners of Piscataquis, and he shall pay the same into the county treasury of said county quarterly on or before the first days of January, April, July and October of each year. The judge of said court shall receive a salary of five hundred dollars per year, to be paid him in quarterly payments from the county treasury of Piscataquis county, which shall be in full for his services as such judge. When the office of judge is vacant the recorder shall be entitled to the same fees received by said judge, the fees of said recorder to be paid by the judge.' So that said section, as amended, shall read as follows:

'Section 20. The judge of said court shall demand and receive the same fees allowed by law to trial justices and clerks of the supreme judicial court for similar services, except that he shall receive for every blank writ signed by him, three cents; for the entry of civil action, fifty cents; for each warrant issued by him, one dollar; for the trial of an issue in civil or criminal cases, one dollar for the first day and two dollars for each subsequent day actually employed; and said fees for the trial of an issue in civil actions shall be paid by the plaintiff before proceeding with the trial each day, to be taxed in his costs, if he prevails. An accurate account of the fees so received by said judge shall be by him laid before the county commissioners of Piscataquis county, and he shall pay the same into the county treasury of said county quarterly on or before the first days of January, April, July and October of each year. The judge of said court shall receive a salary of five hundred dollars per year, to be paid him in quarterly payments from the county treasury of Piscataquis county, which shall be in full for his services as such judge. When the office of judge is vacant the recorder shall be entitled to the same fees received by said judge, the fees of said recorder to be paid by the judge.'

An Act to extend the charter of the Wells Telephone Company.

Be it enacted by the People of the State of Maine, as follows:

Charter ex-
tended.

The rights, powers and privileges of the Wells Telephone Company, which were granted by chapter three hundred and seven, of the private and special laws of nineteen hundred and seven, are hereby extended for two years from the passage of this act; and the persons named in said act, their associates and successors, shall have all the rights, powers and privileges that were granted them by said act, to be exercised in the same manner and for the same purposes as specified in said act.

Chapter 114.

An Act to extend the charter of the Dixfield Trust Company.

Be it enacted by the People of the State of Maine, as follows:

Charter ex-
tended.

All the rights, powers and privileges of the Dixfield Trust Company which were granted by chapter fifty-two of the private and special laws of one thousand nine hundred and seven, are hereby extended for one year; and all the rights, powers and privileges that were granted by said act, may and shall be exercised in the same manner and for the same purposes as provided in said act; provided, however, that said company shall actually commence business as a trust company within the said one year.
